

Mr. A. Dorsey delivers a bill, entitled, An act to ascertain the allowance of the members of the general assembly, electors of the senate, and electors of the president and vice-president of the United States; and Mr. C. Dorsey delivers a bill, entitled, An act for the relief and benefit of Horatio Moore, of Charles county; which were read.

The bill authorising the levy court of Washington county to levy a sum of money for the purpose therein mentioned, was read the second time and passed.

The house, according to the order of the day, proceeded to the second reading of the resolutions for the encouragement of domestic manufactures, and, on motion by Mr. J. H. Thomas, the question was put, That the words "or die all slaves" be stricken out of the preamble? Resolved in the affirmative.

The first and second resolutions were assented to.

The question was then put, That the house assent to the third resolution? Determined in the negative.

On motion by Mr. Archer, the question was put, That the house assent to the following resolution in lieu of the third resolution? to wit: "Resolved, That sheep, to the number of sixty-five, in the hands of any individual, shall not be liable to assessment." The yeas and nays being required, appeared as follow:

On motion by Mr. Archer, the question was put, That the word "woollen" be inserted after the words "uniform of?" Resolved in the affirmative.

On motion by Mr. C. Dorsey, the question was put, That the words "cotton or linen" be added to the last amendment? The yeas and nays being required, appeared as follow:

On motion by Mr. Worthington, the question was put, That the words "domestic manufactures" be stricken out? Resolved in the affirmative.

On motion by Mr. Worthington, the question was put, That the words "the manufacture of this state" be inserted in lieu of the words stricken out? Resolved in the affirmative.

On motion by Mr. Archer, the question was put, That the said resolution be stricken out? Resolved in the affirmative.

The question was then put, That the following be inserted in lieu thereof? to wit: "Resolved, That if forty men, or more, in any company of militia, or troop of horse, within this state, shall cloath themselves in a full uniform of woollen cloth of the manufacture of this state, to be certified to the governor and council by the captain of the troop or company, and commanding officer of the extra battalion or regiment to which such troop or company may belong, they shall be completely armed and accoutred at the expense of the state, provided that sufficient security be given to the governor and council for the safe keeping of such arms, and their return when required." Resolved in the affirmative.

On motion by Mr. Archer, the question was put, That the first blank in the sixth resolution be filled up with the word "ten?" Determined in the negative.

On motion by Mr. Streett, the said resolution was stricken out.
