THE committee to whom was referred the petition of sundry inhabitants of Baltimore and Frederick counties, praying the legislature to pass a law incorporating a company to turnpike a road from the seventh milestone on the Reister's-town turnpike road to Liberty-town, in Frederick county, report, that a law passed some years ago authorising the opening a road from Liberty-town aforesaid to Baltimore, in the nearest direction the nature of the ground would admit of, which road has been surveyed and located so as to intersect the Reister's-town turnpike road at the two milestone ; that the levy court of Frederick county have caused the said road to be opened and completed to the Baltimore county line, and that a considerable part of the road from the two milestone to the line aforesaid is now opened on the part of Baltimore county ; this road, when completed, will open or over the turnpike road leading from Boonsborough to Baltimore ; an election of passing over it free of toll, would in a great degree deprive the citizens of that valuable privilege, and would materially injure much of the property of the citizens through whose lands the said turnpike would pass, as the road now opening, and the road prayed for, would run nearly in a parallel line with each other, ending at the town of Liberty aforesaid ; for the above reasons the committee are of opinion that the petitioners have leave to withdraw their petition.
