vania line, was read the second time and passed.

On motion by Mr. Seth, the question was put, That the words "elect by ballot another person in place of the person first elected, for the residue of his term aforesaid," be stricken out of the eighth clause for the purpose of inserting the words "notify the governor and council thereof, who shall appoint a person in place of

the person first elected, for the residue of his term aforesaid?" Determined in the negative.

On motion by Mr. Archer, the question was put, That the following clause be added to the said bill? to wit: "And be it enacted, That if this act shall be confirmed by the general assembly, after the next election of delegates, in the first session after such new election, as the constitution and form of government directs, that in such case this act, and the alteration and amendment of the constitution and form of government therein contained, shall be taken and considered, and shall constitute and be valid, as part of said constitution and form of government, to all intents and purposes, any thing in the said constitution and form of government contained, to the contrary notwithstanding." Determined in the negative.

The question was then put, Shall the said bill pass? The years and mays being required, appeared as follow:
