laid down, and that the whole of the said tract of land called Purchase was laid, according to the true calls of the survey, upon an elder tract of land called Brereton, and consequently must be lost to the petitioner; but that it has been also discovered, that there is a vacancy between the lines of a tract of land called New Amster on the east, Elk river on the south, St. John's manor on the west, and Johnson's Addition on the north, containing about one hundred and seven acres, the whole of which the petitioner, and those under whom he claims, always, until the present time, held and quietly enjoyed, as supposing the same to be really and truly included under the surveys of New Amster and Purchase; therefore RESOLVED, That the chancellor, on the application of Edward Wingate, of Cæcil county, to be made to him as judge of the land-office, be authorised to inquire into the circumstances relating to the piece or parcel of land alleged to be vacant in manner before mentioned, and if the chancellor shall be of opinion, from the evidence offered to him, that the said alleged vacancy hath, been paid for and held by the said Edward Wingate, and those under whom he claims, under a belief that the same was really included under the surveys of New Amster and Purchase as aforesaid, that then the right of the state to the said alleged vacancy shall be released unto the said Edward Wingate, and the chancellor shall thereupon order a patent to be issued to the said Edward Wingate for the said alleged vacancy, according to the metes and bounds thereof, so that the same do not contain more land than what the said Edward has lost by the erroneous surveys before mentioned.

All which is submitted.

The bill to give validity and operation to the deeds of conveyance therein mentioned, and the bill to settle and ascertain the salary of the members of the council for the ensuing year, were read the second time and passed.

Mr. Forwood delivers a bill, entitled. An act to withdraw the salaries from the militia officers, and to make some provision for the privates; Mr. C. Hall delivers a bill, entitled, An act for the relief of George Jones, of Kent county, an insolvent debtor; Mr. Harryman delivers a bill, entitled, An act annulling the marriage of Edward Welsh, of Baltimore county; Mr. Stevens delivers a bill, entitled, An act to confirm an act passed at November session, one thousand eight hundred and nine, entitled, An act to alter such parts of the constitution and form of government of this state as relate to voters and qualification of voters; and Mr. Bland delivers a bill, entitled, An act concerning partitions, joint rights and obligations; which were read.

Mr. Bland delivers a bill, entitled, An'act respecting the registering of marriages, births and deaths, and a bill, entitled, An act to subject lands to the payment of debts; which were read.
