to the completion of the administration, according to the circumstances of the case, as are prescribed by the 5th chapter of the act to which this is a supplement." Resolved in the affirmative.

On motion by Mr. Brooke, the question was put, That the following be added to the said bill? to wit: "And be it enacted, That no nuncupative will, hereafter to be made, shall be good and available to pass any goods, chattels or money, therein mentioned, provided the whole property therein mentioned, and thereby intended to be bequeathed, shall exceed in value the sum of five hundred dollars." Determined in the negative. The question was then put, Shall the said bill pass? Resolved in the affirmative.

On motion by Mr. Brooke, Leave given to bring in a bill, entitled, An act to subject equitable estates in land to sale under writs of fieri facias. ORDERED, That Mr. Brooke, Mr. Archer and Mr. T. Hall, be a committee

to prepare and bring in the same.

On motion by Mr. Bowie, ORDERED, That the clerk of this house forward immediately to the clerks of Baltimore and Harford counties, a copy of the order requiring them to forward extracts under seal from their records respecting the facts stated in said order, and that the clerk also forward to Zebulon Hollingsworth and Thomas Jones, Esquires, a copy of the order authorising the speaker of this house to issue subponas in the case therein mentioned.

The house adjourns until Monday morning 9 o'clock.
