

ably true, it is only necessary to refer to the petition of the Union Bank of Maryland, and to the law passed last session; in consequence of that petition, authorising the Union Bank to vest 600,000 dollars in the purchase of the public debt, for it was expressly set forth in that petition, made by the president and directors, that this sum, in addition to what was already employed, could not be actually and advantageously employed in the city of Baltimore; therefore, Resolved, That the bill, entitled, An act to incorporate the stockholders of the Franklin Bank of Baltimore, be postponed until the first day of June next.

The house adjourns until to-morrow morning 9 o'clock.

SATURDAY, December 1, 1810.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. T. Hall delivers a petition from Daniel Hefflebower, of Washington county, praying a special act of insolvency; which was read and referred to Mr. T. Hall, Mr. Downey and Mr. Bowles.

Mr. Schley delivers a petition from sundry inhabitants of Frederick county, praying for a lottery for the benefit of Saint Paul's and Apple's Churches; which was read and referred to Mr. Schley, Mr. Cockey and Mr. Swearingen.

The speaker laid before the house communications from the clerk of the court of appeals for the eastern shore, the clerk of Talbot county, and the clerk of Washington county, relative to the attendance of the judges; which were read and referred to the committee of grievances and courts of justice.

Mr. Boyle delivers a petition from James Scott, an old soldier, praying to be allowed a sum sufficient to defray his expenses to the city of Washington for the purpose of receiving his pension; which was read and referred to Mr. Boyle, Mr. Bowles and Mr. Marriott.

The bill for the relief of John Carruthers, of the city of Baltimore, an insolvent debtor, was read the second time and passed.

Mr. Archer delivers a petition from Phœbe Taylor, of Cæcil county, praying for a divorce; which was read and referred to Mr. Archer, Mr. Moffitt and Mr. Groome.

On motion by Mr. Dorsey, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An act concerning servants and slaves. ORDERED, That Mr. Dorsey, Mr. Jackson and Mr. Bland, be a committee to prepare and bring in the same.

Mr. Warfield delivers a bill, entitled, An act to appoint Thomas Woodfield, of Anne-Arundel county, trustee for the sale of the real estate of Joshua Hall, late of said county, deceased; which was read.

The bill for the relief of John Murray, devisee of John Muir, was read the second time and passed.

Mr. Randall delivers a bill, entitled, An act for the relief of James Wilson, of Baltimore county; which was read.

On motion by Mr. Perry, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An act for the valuation of real and personal property within this state. ORDERED, That Mr. Perry, Mr. A. Browne and Mr. Hilleary, be a committee to prepare and bring in the same.

The bill for the relief of John Norris, of Harford county, and the bill for the relief of William Austin, were read the second time and passed.

Mr. Streett delivers a bill, entitled, An act to confirm a road in Harford and Baltimore counties therein mentioned; which was read.

The house resumed the consideration of the amendment proposed by Mr. Emory to the preamble of the bill to incorporate the stockholders of the Franklin Bank of Baltimore; a division of the question being called for, the question was put on striking out. Determined in the negative.

On motion by Mr. Archer, the question was put, That the further consideration of the said bill be postponed until Tuesday next? Determined in the negative.

On motion by Mr. Archer, the question was put, That the same be referred to the next general assembly? Determined in the negative.

On motion by Mr. Archer, the question was put, That the house adjourn? The yeas and nays being required, appeared as follow:
