The question was then put, Shall the said bill pass? Determined in the negative. The house adjourns until to-morrow morning 9 o'clock.

The proceedings of yesterday were read, The bill to widen and alter the direction of Ten Feet Lane in the city of Baltimore, the bill for the relief of Clotworthy Birnie, the further supplement to the act, entitled, An act relating to negroes, and to repeal the acts of assembly therein mentioned, and the bill to confirm an act passed at November session, eighteen hundred and nine, entitled, An act to alter and abolish all that part of the constitution which permits certain citizens of Annapolis to vote for delegates for Anne-Arundel county, and the resolution relative to the settling the western limits between Maryland and Virginia, were sent to the senate.

On motion by Mr. Warfield, ORDERED, That the bill to regulate and confine the duties of constables within

the city of Annapolis, be withdrawn for amenament.

Mr. Harryman delivers a bill, entitled, An act to repeal the twentieth section of an act, entitled, An act to incorporate a company to make a turnpike road to lead from the cross roads near Richard Caton's lime-kiln, in Baltimore county, nearly in the direction of Jones's Falls, to the city of Baltimore; which was read the first and second time by especial order, passed, and sent to the senate.

The supplement to an act, entitled, An act to empower the trustee herein after named to sell certain lands of the late William O'Bryon, deceased, situate, lying and being, in Queen-Anne's county, and for other pur-

poses therein mentioned, was read the second time, passed, and sent to the senate.

THE committee to whom was referred the petition of Samuel Huggins, of Cæcil county, an old revolutionary soldier, beg leave to report, that they have had the same under consideration, and find that he was a brave

soldier during the revolutionary war, and therefore they recommend the following resolution:

RESOLVED, That the treasurer of the western shore be and he is hereby directed and required to pay to Samuel Huggins, of Cæcil county, late a meritorious soldier in the revolutionary war, or to his order, in quarterly payments, a sum of money equal to the half pay of a private during his life, as a further remuneration to him for those services by which his country has been so essentially benefitted.
