

Mr. Forwood delivers a petition from Doctor James Archer, of Claiborne county and Mississippi territory, praying he may be authorised to remove his slaves to Maryland; which was read and referred to Mr. Forwood, Mr. Davis and Mr. Dorsey.

Mr. Randall delivers a bill, entitled, An act annulling the marriage of Samuel Sargeant, and Mary Sargeant his wife, of Baltimore county; which was read.

Mr. R. Hall delivers a petition from sundry inhabitants of Anne-Arundel and Prince-George's counties, praying a confirmation of the road from Richard Dorsey's, of Caleb, to the public road leading from the plantation of Benjamin Ogle, in Prince-George's county, to Bladensburgh; which was read and referred to Mr. R. Hall, Mr. Marriott and Mr. Belt.

The bill to enable Prudence Gough and James Carroll, executors of the last will and testament of Harry Dorsey Gough, to make deeds in certain cases therein mentioned, was read the second time and will not pass.

The bill for the relief of William Maxwell, of the city of Baltimore, and the further supplement to an act, entitled, An act for the valuation of the real and personal property within this state, were read the second time, passed, and sent to the senate.

The clerk of the senate delivers the bill to reduce the per diem of the judges and clerks of elections in Allegany county, endorsed, "on re-consideration will pass." Ordered to be engrossed. Also a bill, entitled, A supplement to an act, entitled, An act to ascertain and establish a divisional line between Anne-Arundel and Calvert counties, endorsed, "will pass;" which was read the first time and ordered to lie on the table. And a letter from the executive enclosing the proceedings of the legislature of New-Jersey on the several resolutions proposed by the legislatures of Massachusetts, Virginia and Pennsylvania, for amending the constitution of the United States; which were read and ordered to lie on the table.

Mr. Martin delivers a bill, entitled, An act for the relief of Henry Brown, of the city of Baltimore; which was read.

Mr. Gaither delivers a report from the trustees of the Rockville academy; which was read and referred to Mr. Gaither, Mr. Wharton and Mr. Boyle.

Mr. Boyle delivers a bill, entitled, An act respecting the issuing of writs of execution out of the court of appeals; which was read.

The bill for the relief of Philemon Towson and Sebastian Groff, and the bill for the benefit of the children of Littleton Robins, jun. deceased, of Worcester county, were read the second time, passed, and sent to the senate.

On motion by Mr. Stevens, the question was put, That the house resolve itself into a committee of the whole on the report in favour of Frederick Green? Determined in the negative.

The house proceeded to the second reading of the said report, and the question was put, That the house assent to the resolution therein contained? The yeas and nays being required, appeared as follow:
