On motion by Mr. Boyle, Leave given to bring in a bill, entitled, An act for the better preservation of the public property. ORDERED, That Mr. Boyle, Mr. Mackubin and Mr. Marriott, be a committee to prepare and bring in the same.

The resolution remunerating the clerks of the several counties who complied with the resolution of the house of delegates passed last session, was read the second time, and, on motion by Mr. Bowie, the question was put, That the blank therein be filled up with 20 dollars? Determined in the negative.

The question was then put on 15 dollars? Determined in the negative.

On motion by Mr. Archer, the question was put on 10 dollars? Resolved in the affirmative.

The question was then put, That the house assent to the same? Resolved in the affirmative.

Stansbury and Peter Little be, and they are hereby declared to be, directors on the part of this state for the ensuing year in the Mechanics Bank of Baltimore; that Nicholas Brewer and William Kilty be, and they are hereby declared to be, directors on the part of this state for the ensuing year in the Farmers Bank of Maryland; that Jacob Gibson and David Kerr, jun. be, and they are hereby declared to be, directors on the part of this state for the ensuing year in the Branch of the Farmers Bank of Maryland at Easton; and that Henry Lewis be, and he is hereby declared to be, a director on the part of this state for the ensuing year in the Hagar's-Town Bank.
