THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. The bill annulling the marriage of William Price, and Margaret his wife, was sent to the senate.

The supplement to the act, entitled, An act for the relief of Anthony Thompson, was read the second time, and the question put, Shall the said bill pass? Resolved in the affirmative, and sent to the senate.

On motion by Mr. Martin, the question was put, That the house reconsider the bill annulling the marriage of William Bartleson and Deborah Bartleson? Resolved in the affirmative.

Which being read, the question was put, Shall the said bill pass? Determined in the negative.

The supplement to an act, entitled, An act for the benefit of the infant children of James Wilson Perry, of Montgomery county, deceased, was read the second time and passed.

Mr. Bennett delivers a petition from Keziah Hutchinson, of Dorchester county, praying for a divorce; which was read and referred to Mr. Bennett, Mr. Frazier and Mr. Martin.

Mr. Marriott delivers a petition from Theodore Mitchell, of Anne-Arundel county, stating that he was married by the name of Swain, and praying that his marriage may be confirmed, and he be authorised to assume the name by which he was married; which was read and referred to Mr. Marriott, Mr. Warfield and Mr. R. Hall.

The clerk of the senate delivers the bill for the relief of Clotworthy Birnie, the bill for the benefit of the children of Littleton Robins, junior, deceased, of Worcester county, the bill to open and make public an alley in the town of Snow Hill, in Worcester county, the supplement to an act, entitled, An act to empower the trustee herein after named to sell certain lands of the late William O'Bryon, deceased, situate, lying and being, in Queen-Anne's county, and for other purposes therein mentioned, and the bill to confirm a road in Harford and Baltimore counties therein mentioned, severally endorsed, "will pass." Ordered to be engrossed. And the bill for the relief of John S. Moffitt, endorsed, "will pass with the proposed amendment;" which amendment was read, agreed to, and the bill ordered to be engrossed. A bill, entitled, An act for the relief of James Fulton, of the city of Baltimore, endorsed, "will pass;" which was read the first time and ordered to lie on the table. And the further supplement to the act, entitled, An act relating to negroes, and to repeal the acts of assembly therein mentioned, endorsed, "will pass." Ordered to be engrossed.

Mr. Randall delivers the following report :

THE committee to whom was referred the memorial of the proprietors of the Woollen Factory at Lanvale, in Baltimore county, report, that the establishment of a woollen factory by the memorialists in Baltimore county, upon so extensive and liberal a plan, promises many permanent advantages to this state, and is highly deserving of the encouragement of the legislature, and that aid which they have solicited in their memorial; the committee therefore recommend the adoption of the following resolution :

RESOLVED, That the treasurer for the western shore of this state be authorised to loan to James Mosher, Robert Cary Long and William Gwynn, proprietors of the Woollen Factory at Lanvale, in Baltimore county, the sum of _____ dollars, on their delivering to him a bond to the state of Maryland, in the penal sum of _____ dollars, to be executed by them, with such security, real or personal, or both, as the governor and council shall approve, conditioned for the payment of the legal interest on the sum loaned in equal semi-annual payments, and also for the payment of the whole sum loaned within _____ years from the date of such bond.
