The clerk of the senate delivers the bill authorising a lottery to raise a sum of money for opening and clear. ing the road to be opened from Westminster, in Frederick county, An act extending and uniting Holliday-street in the city of Bultimore, the bill for the benefit of Luke Tiernan, the bill for the relief of John Lyon, the bill respecting the issuing writs of execution out of the court of appeals, the supplement to the act, entitled, An act to regulate and discipline the militia of this state, the bill for the benefit of Levin Irving, of Somerset county, the bill for the relief of Robert Alexander Smith, of Anne-Arundel county, the bill to subject equitable estates in lands to sale under writs of fieri facias, the bill for the relief of Charles Hi. Willigman, the bill to ratify an amendment to the constitution of the United States of America, proposed by congress, the bill for the benefit of the heirs of Benjamin Gould, of Queen-Anne's county, the bill authorising the levy court of Cacil county to open a road in said county, the supplement to the act to lay out and open a road from the Franklin paper mill, on Gwynn's Falls, to the New Liberty Road, the bill to lay out and open a road from Archibald Dysart's tavern, in Cæcil county, to the Pennsylvania line, the Vill authorising the raising a sum of money to complete the court-house, and to erect a watch-house, in the city of Baltimore, and the bill for the benefit of Samuel Wright, severally endorsed, "will pass." Ordered to be engrossed. The bill for the relief of Linney Conway, and the bill concerning liens, severally endorsed, "will not pass." A bill, entitled, A surplement to an act, entitled, An act to alter the public road leading from Mile's river ferry through the lands of Jacob Lockerman, of Talbot county, endorsed, "will pass;" which was read the first and second time by especial order. passed, and sent to the senate. The resolution to appoint a person to take care of the arms, the resolution relative to investments, the resolution for repairing the stadt-house, the resolution relative to the Penitentiary, and the resolutions in favour of Leslie Roby, William Kilty, Thomas Harris, Henry Thompson, John Sullivan, and Martha Macklefish, severally endorsed, "assented to." And the resolution in favour of James Earle, Junr. endorsed, "dissented from."

On motion by Mr. Stevens, the following resolution was read, assented to, and sent to the senate.

RESOLVED, That the treasurer often western shore pay to James Earle, junior, or order, the sum of sixty-nine dollars and eighty-five cents, out of any unappropriated money in the treasury.

On motion by Mr. Marriott, the following resolution was read and assented to.

sembly? Determined in the negative.

On motion by Mr. Archer, That the blank therein be filled up with 1000 dollars? on motion by Mr. Dorsey, the question was put, That the same be referred to the 12th November? Determined in the negative.

The question was then put on filling up the blank. Resolved in the affirmative.

On motion by Mr. Herbert, That the whole of the resolution be stricken out for the purpose of inserting the

following: "RESOLVED, That the copy right of the report of the chancellor relative to the statutes of England now in force in this state, be disposed of to the highest bidder, under the direction of the governor and council."

A division of the question being called for by Mr. Bowles, it was put on striking out. Determined in the negative, On motion by Mr. Jackson, the question was put, That the same be referred to the first day of June next?

Determined in the negative. The question was then put, That the house assent to the said resolution? The year and nays being re-
