

VOTES AND PROCEEDINGS, NOVEMBER, 1779.

Mr. Lethbrury brings in and delivers to Mr. Speaker a bill, entitled, An act relating to public roads, which was read the first time and ordered to lie on the table.

A report from the commissioners appointed by a resolve of the late general assembly, for opening the roads from the head of Elk to Christiana bridge, and from the head of Back-creek to Hamburg, was preferred and read.

Mr. J. Hall brings in and delivers to Mr. Speaker a bill, entitled, An act to explain the several acts of assembly heretofore made relative to the enrollment of deeds; which was read the first time and ordered to lie on the table.

Mr. Digges hath leave of absence for a few days.  
The petition of the inhabitants of Harford county, relative to public buildings in that county, read the second time and rejected, for want of due notice being given.

Mr. M'Comas hath leave of absence on account of the indisposition of his family.  
The petition from sundry persons inhabitants of Somerset county, relative to a school at the head of Back-creek, was read the second time, and the question being put, That the said petition be granted? The yeas and nays being called for by Mr. Winder, they were as follow:

A petition from David Corbet, of Cecil county, praying to be recompensed for some injury done his house in Charles-town by the soldiery, was preferred and read, and ordered to lie on the table.

On motion, ORDERED, That the committee appointed to inspect into and report the state and condition of the auditor-general's office, do also enquire into and report the state and condition of the books kept by the commillary of stores and quarter-master.

Mr. Worthington, from the committee appointed to report what laws will expire, &c. delivers to Mr. Speaker the following report:

By the COMMITTEE appointed to enquire what laws have expired, or will expire, during the session, or at the close thereof.  
YOUR committee find, that the following laws have expired and will expire in the next session, and at the close thereof: An act to prevent counterfeiting the paper money of other colonies, passed June session, 1773. Expired. An act to regulate the militia, passed June session, 1777, and the supplementary acts thereto, passed October session, 1777, and March session, 1778. Expired. An act for the special appointment of inspectors, and for other purposes, passed October session, 1778. Expired.
