Mr. J. Hall brings in and delivers to Mr. Speaker a bill, entitled, An act to raise the supplies for the year seventeen hundred and eighty; which was read the first time and ordered to lie on the table.

A petition of the reverend Thomas Brown, of Dorchester county, praying to be allowed to take the oath of fidelity, was preferred and read a first and second time by especial order and granted. Leave given to bring in a bill pursuant to the prayer of the said petition.

A petition of Joseph Messenger, of St. Mary's county, was preferred, read a first and second time by especial order and granted, and leave given to bring in a bill pursuant to the prayer thereof.

The bill, entitled, An act for establishing the mode of ordination of ministers of the church of England for the present, was read the second time, and thereupon the question put, That the said bill do pass? carried unanimously in the negative.
