The House met. All present as on yesterday except ~~Mr. Hall~~. The Proceedings of yesterday were read. The Bill, entitled, An Act for the Relief of Henry Stevenson, Sheriff of Baltimore County, was sent to the Senate by Mr. Deye and Mr. Ridgely.

The Bill, entitled, An Act for the Relief of Thomas Lightfoot, a languishing Prisoner in Talbot County Gaol, was sent to the Senate by Mr. Magruder and Mr. Barnes.

The Petition of Thomas Johnson, jun^r was read and referred to the Committee No 2 who are to enquire into and report on the same.

The Bill, entitled, A Supplement to an Act, entitled, An Act to make the Bills of Credit issued by Congress, and the Bills of Credit emitted by Acts of Assembly and Resolves of the late Conventions, a legal Tender in all Cases, was read the second Time, passed, and sent to the Senate by Mr. J.
