By the Committee of Claims, March 23. 1779

Your Committee beg leave to lay before the Honourable House the Journal of Accounts, amounting in the whole to six thousand five hundred and ninety two Pounds, thirteen Shillings and seven Pence. Which is submitted to the Consideration of the Honourable House. Signed by Order W. W. Maepherson

Mr. Norris from the Committee No. 5 brings in and delivers to Mr. Speaker the following Report The Committee to whom the Resolve of Congress of the 9<sup>th</sup> Instant, and a Letter from his Excellency John Jay, President of Congress, relative to filling up our Quota of Troops, was referred, beg leave to report, That in the Opinion of your Committee, the Governor and Council should be empowered (and requested to draw such Sums of Money as may be necessary to forward the recruiting Service, and apply to Congress from Time to Time to reimburse such Sums as may be advanced; and that if need be, they give out Warrants to enlist all able bodied Freemen that may be willing to serve, until the seven Battalions raised by this State be completed; and that the Governor and Council be requested, if they esteem it necessary, to write to his Excellency General Washington, to send some active Officers of the Maryland Line to assist in the recruiting Service aforesaid. All which is submitted to the Honourable House. Signed per Order James Hodges, Esq.
