

Charles Carroll, of Carrollton, Esq: from Maryland, delivers to Mr. Speaker a Memorial of the Corporation of the City of Annapolis, setting forth That St. George's and Dead Streets, and a small Piece of Ground laid out for a Custom House in the said City, are unoccupied and waste, and therefore pray that the Corporation and their Successors may be enabled to sell the same; also praying, that the said Corporation and their Successors may be enabled to lay a Tax not exceeding five shillings in any one Year for every hundred Pounds of Property within the said City and Precincts thereof, for the use of the said City, as the Corporation may think proper: and also praying, that the Power of regulating Ordinarys and Retailers of Spirituous Liquors within the said City and the Precincts thereof may be hereafter vested in the said Corporation, and that the Mayor's Court of the said City may hereafter grant Licences to Ordinary Keepers and Retailers of spirituous Liquors within the said City and Precincts, and that no other Taxes be hereafter imposed on any Ordinary Keeper or Retailer of spirituous Liquors within the said City or the Precincts thereof thus endorsed; "By the Senate November 16th 1779 Read and referred to the Consideration of the House of Delegates *By Order M. Redgely C. T. S.*

The petition of Leonard Gray, a Nonjuror, in Prince George's County, which were ordered to lie on the Table.

Ordered, That Mr. Wootton, Mr. Keene, and Mr. John Hanson be a Committee to take the Bill on the Petition of the Vestry, Church Wardens and Inhabitants, of Christ Church Parish in Calvert County, and the Counter Petition thereunto.

Wednesday November 27th 1779

The House met. Present as on Yesterday. The Proceedings of yesterday were read. Mr. Richard Johns, a Delegate returned for Talbot County, appeared, and after being duly qualified he took his Seat in the House.

The Memorial of the Mayor, Recorder, Aldermen and Common Councilmen of the City of Annapolis, read the first Time and ordered to lie on the Table.

Mr. Fitzhugh brings in and delivers to Mr. Speaker a Bill, entitled, a Supplement to the Act entituled, An Act to make the Bills of Credit issued by Congress, and the Bills of Credit emitted by Acts of Assembly and Resolves of the late Conventions, a legal Tender in all Cases, which was read the first Time and ordered to lie on the Table.

Mr. Hanson brings in and delivers to Mr. Speaker a Bill, entitled, An Act relating to the Estates of deceased Persons; which was read the first Time and ordered to lie on the Table
Mr. Bayly hath leave of Absence until Saturday next.

Mr. Marshall delivers to Mr. Speaker the engrossed Bill No 2 which was read and affirmed to, and sent to the Senate with the Paper Bill hereof by Mr. Gaunt and Mr. D. Hall.

Mr. Hall brings in and delivers to Mr. Speaker the following Report.
