Mr. Spaul brings in and delivers to Mr. Speaker the following Report
 By the Committee appointed to examine the Returns of the Commissioners of the Tax from the several Counties of this State, and make their Report thereon

Your Committee, pursuant to the Order and Direction of the honourable House, have enquired into the Returns of the Commissioners of the Tax, and find, that from the Papers returned by the Commissioners of Saint Mary's County, for the Year 1777, a Balance appears to be due the State of £s, 1066-17, and that no Return appears from said County for the Year 1778. That from the Papers returned by the Commissioners of Kent County it doth not appear that any Settlement was had with the Collector of said County for the Year 1777 or 1778. That from the Papers returned by the Commissioners of Anne Arundel County for the Year 1777, a Balance appears to be due to the Collector the sum of £s, 439-10-072 and that for the Year 1778, a Balance appears to be due to the State of £s, 18,656-15. That from the Papers returned by the Commissioners of Calvert County for the Year 1777, a Balance appears to be due the State of £s, 573-3-572, and for the Year 1778 a Balance of £s, 368-17-072. That no Returns appear for Charles County for the Year 1777 and that from the Returns of the Commissioners of said County for the Year 1778 there appears to be due the State the sum of £s, 611-10-08
