Tenements; and also for all such Mines of Lead, Copper, Iron and other Mines, Furnaces, Forges and other Iron-Works, Tolls and other yearly Profits, and all Hereditaments, of what Nature or Kind they be, situate, lying and being within the said District or Division, with which they are charged, the Sum of One Shilling for every Twenty Shillings of the yearly Value, to be fettled and afcertained as aforefaid, and to after that Rate for every greater or leffer yearly Value. And also all and every Person or Persons, dwelling and residing in the District or Division with which they are charged, practifing Law or Physic, or Trading, Merchandizing, or ming Commerce, as a Factor or Agent for any Person or Persons as asoresaid, within this Province, for every Hundred Pounds, or the Value thereof of fuch Rewards, Peds, Profits, or Advantages what soeven, to him or them: accruing, for or by Reason or Occasion of such their feveral: Professions or Merchandizing as aforesaid, for One Wear, the Sum of Rive Shillings, and fo after that Rate for every greater or leffer Sum, or Quantity, or the Walue therebie And to bring with them, at the Time and Place to affixed for their Appearance, a Certificate in Wris ting of the faid Affelforent, wherein shall be inferted the Names and Sir-Names of every Perfon dwelling and residing in the fald Diffrich or Division, and the Value of the Money, Goods; Chattels and Personal Estate (Debts excepted) of greery of them, shid the Sunrof Money affelled thereon, and the yearly Value of each Public Office, Benefice or Employnione of Profit; enjoyed by every of them, within this Prowinde, at the Tame of taking the faid Affeliment, and the Sim of Money affelled thereon hand the yearly Value of every Annuity, Penkon, Stipend or other yearly Sum, payable or facured to be fiald as aforefaid, to every of them within this Province, at the Time of taking the faid Affestment, and the Sum of Money affessed thereon; and also ج نبر د در the
