Bills relating to Vagrant Stock and Taxation of Dogs, in lieu of the measure proposed, and which failed on account of the hostile action of the House Committee on Agriculture, were reported in the Senate and became laws.

The committee's bill to repeal the article of the code, depriving sheep owners of the right of action for sheep taken from their lands, was passed by the Senate, but being referred in the House to the Committee on Agriculture, it was reported upon adversely.

The bill to amend the act in relation to the use of kindred institutions, nearly all of which are established in or near Baltimore, has superior advantages as a point of location, to any other site that can be found.
