Governor Warfield has decided to appoint Mr. James E. Gorter, of Baltimore, a member of the Supreme Bench of Baltimore, to succeed Judge Pere L. Wickes, who retires on account of reaching the age limit August 14.

THE DEMOCRATIC TICKET.

The outcome of the Democratic Primaries in Queen Annes county last Saturday should prove exceptionally pleasing to the best citizenship of the county, as the character of the nominees is a guarantee of good county government for the next two years, in the event of their election—which is a foregone conclusion.

While the offices are not distributed as well as the majority of the people would like to have seen them, yet, when the fact that the nominees represent the county as a whole and not the districts from which they were selected—coupled with the fact that they are the choice of more than three-fourths of the white voters of the county and perhaps four-fifths of the wealth—the ticket, as selected, is a better one perhaps than would have been the case through manipulation, and, therefore, should appeal to every lover of good and clean government.

Seldom, if ever, in the history of the oldest residents of the county was a cleaner or more capable ticket nominated. There is not a weak candidate upon it; not one who is not able to discharge the duties of the office to which he aspires with credit to himself and satisfaction to his constituents.

The ticket nominated for every office next fall is exceptionally bright, and as a proof of this statement we give below a few strong facts in figures.

In 1905 Mr. Samuel Seney received 7731 votes as the Independent candidate for Clerk of the Circuit Court, which was the highest number of votes received by any candidate on that ticket, and Mr. Eugene L. Dudley received 1369 votes for House of Delegates, which was the highest number of votes received by any nominee on the Democratic ticket.

In the same election C. L. Goodhand received 1385 votes for County Commissioner which was the lowest vote received by any candidate on the independent ticket, and the lowest vote received by any candidate on the Democratic ticket was 1303. In the Congressional election in 1906 Thomas A. Smith, Democrat, received 1794 votes, and William H. Jackson, Republican, 1655 votes, making a total of 3449.

Sixteen hundred and fifty Democrats participated in the Primaries last Saturday, and it is estimated that at least 300 Democrats were kept from the polls on account of thrashing wheat and for other reasons, and that certainly not more than half of the doubtful vote of the county participated in the election. Therefore, it would appear on the surface that the Democrats had pretty close to 2000 votes with which to enter the contest at the next general election, and it is reasonably certain that less than 3500 ballots will be cast, with a probability of from four to six hundred of these being thrown out as defective, the majority of which, it is fair to presume, will be republican votes cast for the independent ticket.

"HOW DO YOU STAND?"

In the issue of the OBSERVER of June 25th, just after the nomination of the Independent Citizens' Ticket, we asked the nominees for Senator and House of Delegates on that ticket, some very pertinent questions as to their stand in the Congressional election of 1906, and as to their intentions in selecting the successors of Hons. William Pinkney White and Isador Rayner in the United States Senate. As these candidates

are seeking Democratic suffrage in the county, it is but proper that their stand should be known upon these questions, but so far they have refused to answer the questions propounded to them, that issue of the OBSERVER, and by so doing, by action if not by word, say to the voters—or rather the Democratic voters—of this county that it is now their privilege to interview them upon their political record.

While this may be the view taken by the Legislative candidates on the Independent Citizens' Ticket, we feel absolutely certain that the Democratic voters of Queen Annes county will not be satisfied with their silence.

We now propound the same questions, in the same manner, to the Legislative nominees on the Democratic ticket, and say to them, as we did to the Independent candidates, that the voters of this county will not be satisfied with evasive answers. They have a perfect right to have your declarations before they decide to give you their support, therefore your answers are awaited with no little interest.

The Democratic voters of Queen Annes county demand to know, in the first place, whether or not you, Mr. J. Frank Harper, voted for Hon. Thomas A. Smith last fall, or for Wm. H. Jackson, and they demand to know the same of Messrs. John P. Roe, W. J. Massey and Dudley G. Roe.

Secondly, whether you, Mr. Harper, if elected, will vote for Democratic representatives for United States Senators to succeed the Hons. Isador Rayner and Wm. Pinkney White, and the same demand is made upon Messrs. John P. Roe, W. J. Massey and Dudley G. Roe as to the successors of Hon. William Pinkney White.

We again ask the Legislative candidates on the Independent Citizens' Ticket the same questions, as it is not our intention to make "fish of one and fowl of the other."

Gentlemen, the voters of Queen Annes county await your answers.
