Large Potato Crop.

The potato crop of the Eastern Shore of Maryland this year will probably be the largest on record. So far this season there has been an increase of about 75 per cent. in the yield over that of last year, which was looked upon as being about normal. This increase is attributed to the weather conditions which prevailed this spring, being such as to cause the crop to flourish. The shipments have been so heavy as to cause the Baltimore, Chesapeake and Atlantic Railway Company to place several extra boats in commission on the routes touching at the wharves in that section.

The present shipment amounts to about 30,000 barrels per week over the above line. In addition to this, there are a large number of potatoes being shipped North on the New York, Philadelphia and Norfolk railroad. A large percentage of the crop which is handled by the steamers is transferred and sent to the West and Northwest.

Concrete Bridge.

The first concrete bridge to be erected in Queen Annes County has been completed at Centreville, the one that spans the stream at the foot of the Water Works Hill. The bridge has been in course of construction for over a month and now presents one of the most substantial structures of this kind that can be built. The foundation and lower walls are composed of concrete and the railings on each side of the bridge are of jointed iron. The structure which was formerly built across this stream, had, in the last few months, become very dilapidated and in an unsafe condition, which was caused chiefly by traction engines crossing and recrossing.

The adoption of the concrete plan is a decidedly wise move from every point of view, as it will not only guard against future work, expense and trouble, but will be safer for its users. The contractor for building the bridge was George H. Trax, of Easton.

Order of Publication.

Elizbeth Morden, Plaintiff,

Richard Morden, Defendant.

In the Circuit Court for Queen Anne's County, in Equity. Cause No. 1745.
The object of this suit is to obtain a divorce "a vinculo matrimonii" by the plaintiff from the defendant.
The bill avers that the parties were married on the 25th day of May, in the year 1895, in Queen Anne's county, and that they resided in Queen Anne's county until 1895; that on or about the 2nd day of July, in the year 1895, the defendant abandoned and deserted the plaintiff without just cause; that such abandonment has continued uninterruptedly every since said date, and is deliberate and final, and the separation of the parties is beyond a reasonable expectation of reconciliation; that on the 15th day of July, in the year 1897, the plaintiff filed a petition in this court that the writ of subpoena had been issued on two different occasions for the said Richard Morden, and the same were returned "non est" by the sheriff of Queen Anne's county, and the Plaintiff prayed for this order of publication.

It is thereupon, this 15th day of July, in the year 1907, ordered by the Circuit Court for Queen Anne's county, in Equity, that the plaintiff, by causing a copy of this order to be inserted in some newspaper printed and published in Queen Anne's county once a week for four successive weeks on or before the 15th day of August, in the year 1907, give notice to said defendant of the object and substance of this bill, warning him to appear in this Court in person or by Solicitor on or before the second day of September in the year 1907, to show cause, if any he may have, why a decree should not be entered as prayed.
