Two years ago the Democrats were sluggish and allowed themselves to be defeated, which they realized a few days before election. This year they are united and are working as never before, and victory is assured.

A RIGHT calculated to nauseate most any white person was that witnessed Thursday in the courtroom, where the two Independent Bosses, James T. Bright and H. B. W. Mitchell, were working with might and main to have erased from the poll books the names white voters, and at the same time striving with all vigor to have negroes retained. And these two gentlemen claim to be Democrats, too!

THE OBSERVER has always stood for the best citizenship and progress of Queen Annes county, and today it realizes and recognizes its position in this community to the fullest extent. Never has it been a party to any scheme or device to deprive the highest citizenship of this county of their rights in any particular. For more than forty years it has advocated the supremacy of the white race, and it is stronger today in its conviction that for the best interests of the whole people of this county the Democratic party should be in control.

ADMIT THEIR DEFEAT

Mr. John F. Roth, Independent Citizens' candidate for Register of Wills, was in Centreville one day last week and admitted to a well known citizen of this town that he did not believe he could be elected, and, we understand, that two other candidates on this same ticket have acknowledged their defeat. Were it not for the fact that their leader, Mr. James T. Bright, kept them bolstered up by his "bluff" game of claiming a tremendous majority, every candidate on this ticket would have long since thrown up their hands and cried enough.

HOW ABOUT THIS TRICK?

Mr. Lemuel C. McGinnis, Independent nominee for State Senator, secured two letters—one to the Board of Election Supervisors and the other to James T. Bright—which he purports to be signed by Mr. Charles F. McGinnis, Independent Republican candidate for Judge of the Orphans' Court, declining this nomination, and asking that his name be taken off the ballot. In the first place the request was not filed in time, nor was this declination in legal form, consequently the Board of Election Supervisors could not act upon it. In the second place, it is not believed that Mr. Charles F. McGinnis signed these letters, or even knew their contents. Mr. Charles F. McGinnis was interviewed by a well known Democrat on Thursday, October 31st, and the letters are dated October 30th—and he would not tell what course he had pursued, only stating that he had said he did not care to run and was willing to have his name taken off the ballot. Mr. McGinnis is said to write in a very ordinary hand, yet these letters are signed in a spencerian manner. One thing, at least, is very significant. Mr. Bright took good pains not to even file the letters with the Supervisors, or give anyone the chance to know the genuineness of them. The whole matter, it is believed, is a trick of Mr. L. C. McGinnis and Mr. James T. Bright to make it appear that a man was nominated without his knowledge or consent.

REMEMBER, you can vote for but one candidate for County Commissioner from each district. If you vote for more than one in the same district you will be counted as the ballot will be void.

ESTIMATE

As the county has closed, and the vote of the battle has been reached, the Democratic Campaign Committee, Messrs. Edwin S. Brown, Clayton Wright and W. J. Prior, Jr., has waged an intelligent and telling campaign from the beginning. Every department of work has been thoroughly systematized, and every section of the county polled by practical men. Therefore, the material in the hands of this committee places it in position to give a very accurate forecast of the outcome of the election to be held next Tuesday.

This estimate has been tabulated, and the Campaign Committee claim a majority of not less than 500 for the local Democratic ticket, their claim being backed by the strongest possible proofs obtainable. Mr. Edwin H. Brown, chairman of this matter Saturday, said: "The battle is won, and Queen Annes county will be Democratic this year by not less than 500 majority. We have waged a clean, but aggressive fight, and its effect upon the Democratic voters has been magical. We have taken from the enemy's camp of two years ago not less than 250 of their strongest and most intelligent followers; we have gained not less than 200 of registration, and the sympathies of the white people of the county generally are with us. Therefore, the only thing that is left for us to do is to see that our followers get to the polls and cast their ballots intelligently, when our victory will be a sweeping one. This will be done upon the same systematic lines which has characterized our entire campaign work. This is a white man's county and the white people have determined that the dominant party shall be composed chiefly of white people."

OPEN LETTERS

To the People of Queen Annes county.

In a letter in the last issue of the Centreville Record, signed "Queen Annes Voter," the charge is made that I am "asking members" of "my own and other churches to support me in the coming election and by the same time using the church as a cloak."

I am greatly surprised to learn that any one is willing to print such a statement about me. I am still more surprised that any one, even though he may hide behind the cowardly guise of an anonymous name, should be willing to drag into the field of political controversy the sacred name of the Church. While I do not feel that a denial of this remarkable statement is necessary, yet in order that my position may not be misunderstood, even by the writer of the letter, I do not hesitate to say emphatically and unequivocally, that I have never pursued such a course. There is a limit beyond which we should never allow the exigencies of political campaigns to carry us, and I regret that this writer, in his anxiety to make an unfair attack upon me at the eleventh hour, should so far trespass upon the proprieties of legitimate argument as to make this unworthy attempt to misrepresent me before the people of my county. I deem it a sufficient answer to his charge to say that I hold the Church too sacred to even attempt to do, directly or indirectly, what this writer, in his misguided zeal, charges me with doing.

In my canvass of the county, both in my public addresses and private conversations, I have made a sincere effort to be straight-forward and fair in the discussion of the issues of the campaign. I have especially refrained from any kind of abuse or personal criticism of the candidates on the opposing ticket and have tried to avoid saying anything that might justly be construed as a misrepresentation of the motives or purposes of those who do not agree with me politically. Now that the campaign is about to close, I feel that I have fully and fairly made known to the voters of this county my attitude toward the candidates on the opposing ticket. NOW I will take this opportunity to emphasize that attitude by saying now, without qualification or reservation, that I have made no pledges or promises to any person, persons, associations, or organizations, in this campaign on any subject of legislation, except the promise that, if elected to the Senate, I shall endeavor to conscientiously discharge the duties of the position in the spirit and letter of my official oath.

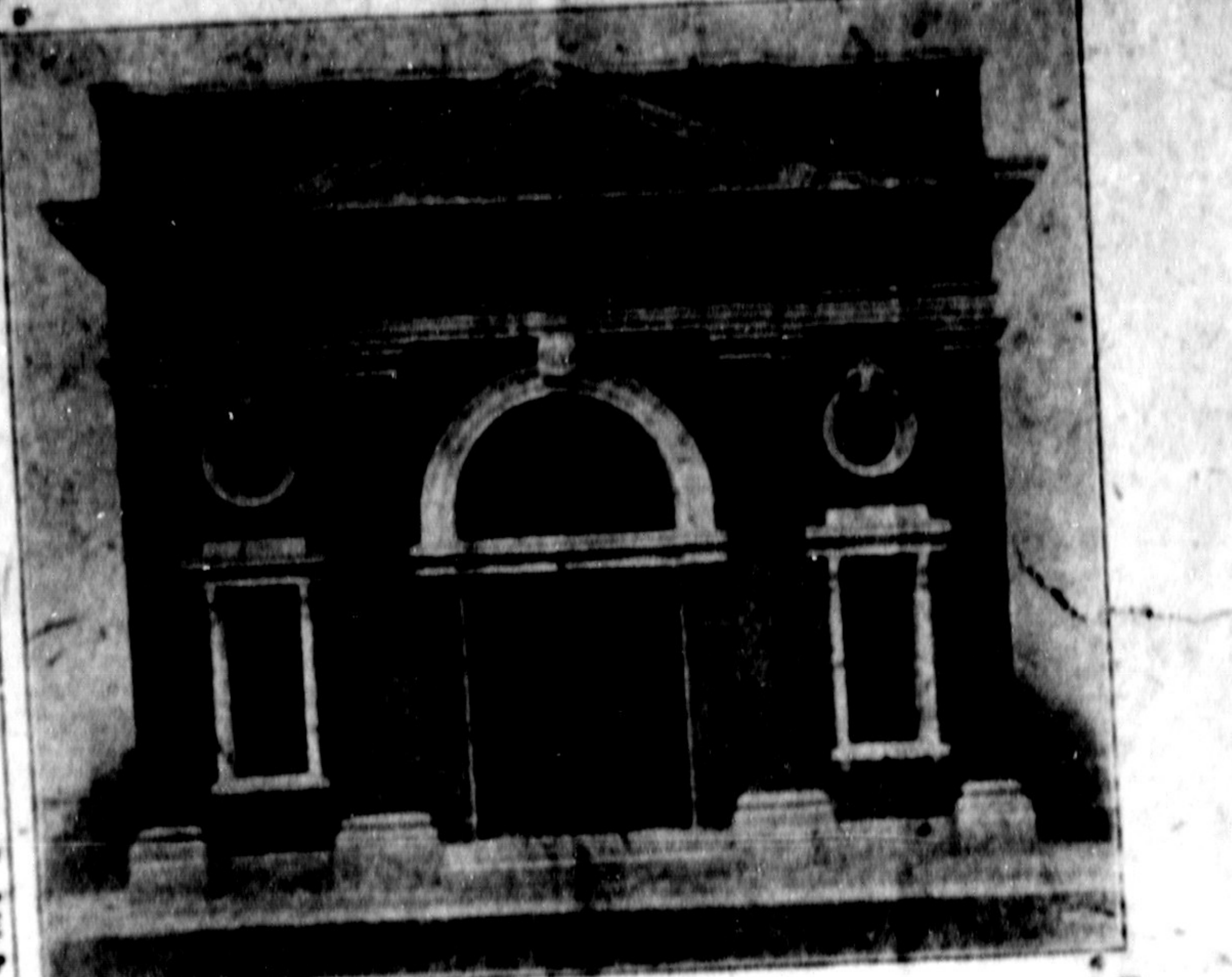
