

Contested Election Case.

Judge P. R. Hodder last Saturday signed orders in the contested election case in which petitions were filed in the Circuit Court of Queen Anne's County by the independent candidates for County Commissioners and Sheriff against the Democratic County Commissioners and Sheriff, requiring them to answer the petitions on or before the fourth Monday in January. Judge Hodder also signed an order appointing George A. Whitley to serve the papers on Sheriff William S. Delaney, who is now acting as Sheriff, and whose office is contested.

The case will, in all probability, be argued before the next January term of court. But if it is not, then a time will be agreed upon by counsel for the taking of testimony.

The appealed injunction suit, which the Independents lost before the Circuit Court, has been sent to the Court of Appeals.

For Extension of Term.

Among the petitions introduced in the Senate Monday night was one by Senator Godlin, of Caroline, which requests the Legislature to extend the term of Chief Judge James Alfred Pearce, of the Second Judicial Circuit. There is a general demand throughout the counties composing the Second circuit of Cecil, Kent, Queen Anne's, Caroline and Talbot for the extension of Judge Pearce's term. Not only are his services upon the bench highly regarded by lawyers and people of those counties, but he is considered one of the ablest members of the Court of Appeals, and there is a general desire that he be allowed to continue his work in the State's highest tribunal. Judge Pearce will reach the age limit of 70 years before the expiration of his term and before the next legislative session.
