

--New York is at last becoming alive to the necessity of having a reliable and accurate daily announcement of time in the port, and arrangements have been made with the Superintendent of the Naval Observatory and the Western Union Telegraph Company for disseminating the standard time, as discovered by the Naval Observatory, to ship owners and masters, business men, railways and chronometer makers. For some time a system of time guns and signal balls has been in use in the principal ports of Great Britain and other European countries, as also in Asia, Australia and Canada. In Great Britain the clock at the Royal Observatory, Greenwich, is connected by electricity with the Liverpool, Edinburgh and other ports, and at the hour of 1 P. M. a signal gun is fired at these places announcing the standard time. The method adopted in New York is a time ball, which is hoisted on the flag-staff of the New York Custom building by means of a light cable wound a cylinder in the clock compartment of the tower. The cable is held by a bar attached to a magnet and this magnet is connected with a wire which can be joined to the Washington circuit. At about forty seconds before 12 o'clock each day, New York time, the wire connecting the Naval Observatory clock is connected with the instrument in the cupola of the building, and when the sidereal clock at Washington tells 11 hours, 47 minutes and 49 seconds the bar holding the reel which secures the ball in position is released, the reels spin around and the ball comes down. It is dropped from a point 250 feet above the sidewalk, and can be seen by silhouettes against the harbor. The preparations are also being made to transmit the standard time by telegraph to all who desire it in the principal cities of the country.

A time goes on the languages spoken in the world and they grow fewer. Three hundred years ago German was beginning to disappear as a spoken language, and a similar fate is now being experienced by the Breton, in many respects a kindred dialect. A Breton sailor told a traveller that three generations of his family were alive--his father, who only spoke Breton; himself who spoke French and Breton, and his son, who only spoke French. So in Ireland every year the number of those speaking Irish decreases. Twelve years ago a tourist in Kerry met a well-dressed young man of the farmer class on a country road, of whom he asked some questions, which were answered very politely, but very little to the point. At length he said: "Pruth is, sir, I can speak very little English." Asking some words to the peasant woman in the carriage for some milk, they made signs for him to wait, and called a man, who interpreted. The rising generation, however, nearly all speak English except some on the wild Atlantic washed islands. In the Isle of Man it is as described in Breton. The Welsh, however, stick to their vernacular, and when you get into a rural district in a county contiguous to the English border, you might most likely find a man in Russian. A famous English Judge, who on one occasion observed, "There is a degree of cunning and duplicity revealed in the conduct of this case such as is, I regret to say, not uncommon in the principality," used to aver that the Welsh stuck to their vernacular in great measure to defeat the ends of justice.

How legs and knock-knees are among the commonest deformities of humanity, and wise mothers assert that the crookedness in either case is a rise from the afflicted cleaving been put upon his or her feet too early in babyhood. But a Manchester (England) physician, Dr. Manchester (the name is not given), who has been watching for the true cause thinks differently. He attributes the first mentioned disorder to a habit some youngsters delight in, of rubbing the sole of one foot against that of the other; some will go to sleep with the soles together. They appear to enjoy the contact only when the feet are naked; they do not attempt to make it when the feet are shod or slippers. So the remedy is obvious; keep the baby's soles covered. Knock-knees the doctor ascribes to a different childish habit, that of sleeping on the side, with one knee tucked under the hollow behind the other. He has found that where one leg has been bowed inward more than the other, the patient has always slept on one side, and the uppermost member has been the most deformed. Here the preventive is to pad the inside of the knees, so as to keep them apart, and let the limbs grow freely their own way. All of which is commended to mothers who desire the physical uprightness of their progeny--Popular Science Monthly.

A war correspondent writes: "I was informed the other day by an eye-witness of a characteristic incident which occurred during Soboleff's attack upon Plekva, on the extreme left of Schakoff's division. When his battalion of infantry (comprising his cavalry company) came within the range of the twelve guns defending that portion of Turkish line, the soldiers began shouting to 'charge,' and commenced rushing forward. Soboleff ordered a halt, the men were dressed into line, and the command given, 'Carry arms,' 'Present arms.' When the line was at a 'Present' the shells began to fall among them. Soboleff then asked them if they did not think 'they presented a ridiculous spectacle in that position under fire.' They replied that they did. Then he assured them that he would keep them there until the next day unless they promised to keep order in the ranks and await the commands of their officers, instead of yelling and charging like their own account. The men assured him that they saw the force of his remarks. They were then led forward, and behaved splendidly during the whole action.

In the taxables of Brooklyn, says a local paper, appears the name of a German whose annual payments for taxes exceed those of many of the so-called princely merchants who live on the Heights. He pays taxes nearly upon real and personal property assessed at \$200,000, but worth probably double that amount. Yet this man works hard at the bench every day, and if he spends a dollar in recreation for his wife and children on Sunday he thinks it a big thing. He has no help, but works for a few customers, doing all their work and caring nothing about any of them. If they are displeased with his way of doing things, he simply says that he can take their work elsewhere, and he sorely tries their patience by his habit of disappointing his customers as to time. This man collects his own rents, builds two or three new houses every year, and from his frugal habits promises, if his life is long spared, to be one of the wealthiest of all the Brooklynites. His yearly income from real estate is not less than \$15,000 per annum, but he regards idleness as a sin, and works away every day upon boots and shoes as regularly as if his bread and butter were in jeopardy.

A convict in the Gundagai jail in Australia, undergoing a term of imprisonment for stealing a ring, used to gain a living by travelling from town to town giving performances in which he offered to swallow any article his audience might select. The ring for the stealing of which he had been convicted he had swallowed, and he asserted he could swallow a bagful if he got them. The prisoner is at present being treated by the visiting surgeon to the jail, with the view of making him disgorge a steel Albert chain and a large brass ring. The chain can be dislodged by the bottom of the stomach, and the patient says he swallowed it nine months ago, and that it is the only article he has had any difficulty about. He says that he has had two pounds' weight of jewelry in his stomach at one time, and that he has harbored watches in that viscus for twenty-four hours. The jailer has a collection of Albert chains, pen-knives, razors, etc., which he asserts he has succeeded in causing the prisoner to vomit by means of emetic.

The defalcation--for it amounts to that--of President Morton, of the West Philadelphia street car company, is the greatest scandal in the history of the city, and has supplied for many a long day. Mr. Morton not only enjoyed the reputation of being one of the most capable and enterprising business men of the time, but possessed public confidence to an unusual extent. It is little more than a month ago since he assumed the presidency of the Permanent Exhibition company, to which post he was chosen solely because of his excellent business habits, and it should be said for him that in this brief period he made the institution not only popular but peculiarly profitable. It is not altogether plain yet whether he personally reaped any of the benefits of the fraud which has at last brought him low, but there is a mulishness in the way in which he shoulders the whole responsibility, and announces his determination to face the result, be it what it may, that affords a refreshing contrast to the usual course of men in similar misfortune.

The most interesting incident in business affairs is noted by the New York correspondent of the Philadelphia Ledger as being a decline in the gold premium to 23, the lowest figure touched since the beginning of the civil war. At this rate, with a continuance of imports from abroad (the steamer City of Chester brings \$29,500) it is believed the premium will be gradually wiped out in a short time, resumption thus solving itself without the aid of quick medicine. There are but few "hours" held enough to venture to "sell short," while merchants and bankers alike are looking forward to the time when Government paper will be as good as gold. The only skeleton in the closet is, that as soon as Congress meets there will be a movement on the part of some of the Western members to repeal the Resumption Act, the effect of which would, of course, send everything to sea again.

As Lady Stowe and some of her companions are conducting the affirmative crusade, there is a pretty fair chance that the grant will not be made.

The Frederick Examiner says that eight suits have been docketed at the present term of the Frederick County Circuit Court, against the Baltimore and Ohio Railroad Company, growing out of the Point of Rocks accident. Among them is one by G. F. Snouffer, claiming \$10,000; W. H. Snouffer, \$5,000; Q. S. J. Beckley and wife, \$10,000; Q. S. J. Beckley, \$5,000; Charles Litter, \$10,000, and Lewis O. Castle, \$10,000.

Holland had, according to her last census on the 1st of June, 3,805,456 inhabitants showing an increase of 55,929 persons, or 1 1/2 per cent. since June 1, 1876. The following was the population of the ten largest Dutch cities on June 1, 1877: Rotterdam, 299,000; Rotterdam, 136,230; Groningen, 104,093; Utrecht, 66,103; Leyden, 41,293; Groningen, 40,590; Arnhem, 33,017; Harlem, 31,707; Maastricht, 29,031; Leeuwarden, 27,085.

Ten Texan cattle breeders own 1,025,000 cattle, besides horses and mules, and have 633,000 acres of enclosed pasture. In 1870 the statistics showed that the state contained 434,504 horses, 61,322 mules and asses, 128,018 milch cows, 132,409 oxen and 2,933,015 other cattle, or for all the owners in the state only 2,469,000 more than are now owned by ten men alone.
