

GENERAL SUMMARY.

MONDAY.

The New Jersey Court of Errors and Appeals at Trenton decided on Saturday the question of setting aside the judgment of the Camden court in the case of Hunter, who was convicted and sentenced to be hanged for the murder of John M. Armstrong.

Miss Louisa W. King, one of the most accomplished and prominent women of the South, died at Augusta, Ga., Saturday night, after a very brief illness.

A reception to Col. J. M. Keating, editor of the Memphis Appeal, in recognition of his heroic fidelity to professional duty during the recent yellow fever epidemic, is to be given by the New York Press Club on Thursday evening next.

TUESDAY.

In the United States Senate, yesterday, among the bills presented was one for the better protection of life in marine disasters, and another for promoting the efficiency of chaplains in the navy.

In the House among the bills presented were the following: To exempt from taxation banks and institutions having no capital stock; to repeal the United States election supervisors' laws; compelling national banks to receive the standard silver as equivalent to gold coin; to make subsidiary coins a legal tender for all government debts more than six months due; to enforce the fourteenth and fifteenth amendments of the constitution.

As regards the cotton crop it is reported from sixteen counties in North Carolina and Virginia that the weather for gathering during November was more favorable than last year, and that the yield, as a whole would be about the same. The same average state of affairs is reported from Alabama, Mississippi and Tennessee.

A hitch has occurred in the negotiations between Turkey and Russia in regard to Turkey insisting that Russia shall not act simultaneously with the surrender of the positions ceded to Montenegro.

The Italian Chamber of Deputies has rejected a vote of confidence in the Government to maintain order with liberty. A report that the Parliament would be dissolved is not credited.

FRIDAY.

In the United States Senate, yesterday, bills were passed making appropriations, authorizing the public printer to print and bind documents for members of Congress on payment of cost and 10 per cent. additional, correcting the error in the sundry civil bill of the last session caused by the omission of the Hot Springs clause, and the West Point Academy appropriation bill, the last named with Senate amendments. The committee to prepare a plan for the reorganization of the army made a report, accompanied by a bill, which was made the special order for January 8. The bill reduces the number of Generals to six, and limits the strength of the army to not more than 25,000 men.

subsidary coin for trade dollars. Mr. Whyte introduced a bill granting patents to the widows of Gen. R. A. Buel, and Edward S. Winder, United States army. The bill to regulate the counting of the vote for President and Vice-President was advocated by Mr. Morgan, of Alabama, and opposed by Mr. Jones, of Florida.

The House took up and passed, with two slight amendments, the consular and diplomatic bill, which appropriates \$1,033,435, being \$140,200 below the estimate. The House also passed, without a single amendment, the naval appropriation bill. The bill appropriates \$11,058,419, which is \$93,000 less than last year's appropriation. This makes four of the appropriation bills that have already passed.

G. W. Hampton, of S. C., who received such serious injuries to one of his legs some time ago by being thrown from a mule while hunting, had the wounded limb amputated yesterday below the knee. His system is believed to be in such condition as to promise hopeful results. The incident was not unaccompanied by other encouraging circumstances. The United States Senate, yesterday, elected him to the United States Senate, only two republicans voting against him.

The Anchor Mill at Minneapolis, Minn., owned by Chas. A. Pillsbury & Co., was burned Monday night, the first loss originating, as in a former case, in the explosion of flour dust. The mill had two rows of stones, and employed twenty men. Loss \$75,000; insurance \$15,000. At Stenton, near Allentown, Pa., yesterday, Kestermacher's Hotel was burned; loss \$5,000.

United States Minister Foster gave a Thanksgiving ball at the legation in the city of Mexico Thanksgiving night. Two hundred persons were present, including President Diaz, the diplomatic corps and many Congressmen. The Thanksgiving proclamation of Minister Foster, written in Spanish. Mr. Foster, in a speech, returned thanks for donations to the yellow fever fund.

In the United States Senate, yesterday, Mr. Beck introduced a bill to repeal the section of the Herried Statutes which prohibits any person who held position under the Confederate government from holding any position in the army of the United States. The fortification and military academy appropriation bills were reported. Mr. Blaine called up his resolution of inquiry as to whether the constitutional rights of citizens had been violated in the recent elections in any of the States. Mr. Blaine spoke in favor of his resolution, when a spirited debate ensued, participated in by Messrs. Thurman, Lyman and Edmunds. Mr. Blaine urged his purpose to press for a vote on his resolution as early as possible. Mr. Thurman offered an amendment to the resolution, so as to inquire whether in the year 1873 levies of money had been made upon officeholders for election expenses, and, if so, how such money was expended; whether any citizen of the United States had been dismissed or threatened with dismissal from employment by reason of his vote at an election, to vote, and as to the conduct of United States supervisors and marshals, &c., at the recent elections.

The House, by a vote of 159 to 101, passed the bill reported last year from the committee on commerce, to regulate interstate commerce. The Geneva award bill was then taken up and read, after which the House adjourned, Mr. Willis having the floor.
