TERMS OF COUNTY COMMISSIONERS. It does not seem likely that any general law regulating the terms of county commissioners under the change in the State constitution will be agreed upon by the legislature, and the matter will be regulated for each county by local law.

A Beautiful Phenomenon in the Northern

In the effective groupings, light was at first a vivid rose-red, but | timely exits, and entrances and telling gradually diminished in intensity to a delicate pink and then to a violet hue. after which it was no longer distinguishable from the clear sky. The illumina-tion was streaked with rays of almost white light, and in addition the more brilliant stars, particularly the polar star, could be distinguished amid the brilliant color. The phenomenon is very rare in this latitude, although common farther north, and is supposed to be due to the highly electrified condition of the atmosphere. This theory has recently been sustained by an interesting series of experiments undertaken by two Swedish astronomers-Lemstrom and Tromholt. By means of a network of

electric currents between two mountains they succeeded in producing several artificial auroras. There is a further theory that these electrical disturbances are connected with the appearances of spots on the surface of the sun, and the phenomenon of Saturday seems to confirm this view, as there is now a spot on the sun capable of being seen with the naked eye. If the weather continues cold and clear, it is likely that the phenomenon will be repeated.
