I believe that four years hence Mr. Gorman will be the strongest candidate in the party, and he can well afford to wait, for his popularity and influence are growing daily. Available as he may be to day, he will wait for more so for the next Presidential race.

FROM THE NATIONAL CAPITAL.

Senator Sherman's Speech Against Free Silver-Other Matters. Senator Sherman, of Ohio, can always count on a large and interested audience whenever he speaks on money or matters of finance. This was demonstrated Tuesday in the Senate when he took the floor in opposition to the free coinage bill. He made the point in the beginning that the question in hand was not partisan, suggesting to his auditors the undeniable fact that Democrats and Republicans are alike split up on silver, but that the matter was one of local bearing, the silver-producing states having in view the single purpose of finding a market for their great commodity.

The opposition to the Hatch anti-trust bill is gaining considerable strength in the Senate, and it is probable that it will be defeated upon the final vote if it is taken up at all. Mr. Page, of Maryland, says he will oppose the bill for two reasons—first, he believes it is unconstitutional, and secondly, he does not believe it would be effective to accomplish the purpose for which it is intended.

The free coinage bill, which was in session in Washington for several days, adjourned Saturday. Liberal contributions and pledges were made for carrying out the work of the newly formed National League. General Warner, the chairman of the convention, says the meeting was the most successful and important of any ever held.

The United States Senate Friday of last week passed a bill to reclassify and prescribe the salaries of railway postal clerks. The rates fixed are: First class, not exceeding \$200; second class, not exceeding \$180; third class, not exceeding \$160; fourth class, not exceeding \$140; fifth class, not exceeding \$120; sixth class, not exceeding \$100; seventh class, not exceeding \$80.

In the House Friday of last week Mr. Hatch's motion to take up the anti-trust bill was defeated by a vote, 119 to 108.

Governor McKinney has appointed Gen. Eppa Hunton United States Senator from Virginia to fill the vacancy caused by the death of Hon. John S. Barbour.

HONORING DEAD HEROES.

Ex-President Rutherford B. Hayes delivered an address before a large assemblage of veterans at Columbus, Ohio. A statue of Lieut. Gen. A. P. Hill was unveiled at the same place. The unveiling of a large assemblage, including Confederate veterans and military from all over the State. Gen. James A. Walker, of Wyeville, delivered the oration.

The feature of Decoration Day observances in Maryland was the fraternalization of ex-Union and ex-Confederate soldiers and officers. A Carrol county, Gen. W. G. Veal, of R. E. Lee Camp of Confederate Veterans, Fort Worth, Texas, made a speech.

In Annapolis a battalion of 120 sailors and marines from the ships of the North Atlantic squadron joined with local organizations in the ceremonies of the day.
