HANGED AT ROCKVILLE.

Murder of Margaret Cephas. William Bond, colored, was hanged in the jail-yard at Rockville, on Friday of last week, for the murder of Margaret Cephas, also colored, on November 22, 1891. The prisoner made no statement from the scaffold, but admitted his guilt privately before he was executed. Promptly at 1 o'clock P. rap. A hymn was sung and a couple Two of the deputy sheriffs quickly asended and replaced it in position. Sheriff Fairall then stepped upon the pedal, the trap fell and Bond was aunched into eternity.

The trap was sprung at 1.12 o'clock The prisoner's neck was broken by the fall, which was about seven feet. A few contractions of the muscles ensued and in seven minutes he was pronounced dead. The body was taken down at 1.30 o'clock and soon after removed to the almshouse, about one and a-half miles from Rockville, where it was buried.

Several colored clergymen spent the night with Bond. The early part of the evening was passed in singing and pray ing, but about two o'clock Friday morning the prisoner threw himself upon the bed and slept until eight o'clock. He then arose and ate a hearty breakfast, April, 12 days 21 hours; May, 13 days 21 which was the first meal of any account he had taken for several days.

The condemned man made a confession, which the Rev. Logan Johnson took down on paper. He stated that he was drunk on the day of the perpetra tion of the crime, that he had pursue and caught the woman, knocked he down and outraged her; that he choked her to keep her from screaming, but did not know that he had killed her until he

The prisoner, it will be remembered was convicted wholly on circumstantial evidence, but the evidence was so strong as to leave hardly any doubt as to hi guilt, though it was urged in his behalf afterwards when a new trial was sought that the woman had died in the road of epilepsy, to which she was subject Bond was to have been hung February 15, but Governor Brown granted a respite until Friday, 14th inst., refusing to interfere further with the course o the law.
