PROCLAMATION BY THE GOVERNOR. STATE OF MARYLAND. EXECUTIVE DEPARTMENT. WHEREAS, Section one of Article fourteen of the Constitution of Maryland makes it the duty of the Governor to cause to be published in certain newspapers to be designated by him, any bill or bills, passed proposing any amendments to the said Constitution; and Whereas, by the said Constitution, and by the Act of the General Assembly of Maryland, a bill was passed proposing an amendment to the Constitution, which amendment is Chapter 213 of the Acts of 1892, and is as follows: to wit:
