Knowing citizens have been discussing every phase of the question and what has been left unsaid could, doubtless, be written on a very small sheet of paper. The general sentiment seems to be in favor of putting water into the town, but the question of cost remains an unsolved problem. If the cost threatens to be very heavy of course waterworks will a thing for future generations to consider. A Times representative has learned from Mayor Sykes that the question will not be offered to the people until definite estimates have been obtained. Water works in Ellicott City would be of immense advantage in many ways, but thus far a number of obstacles have loomed up which seem for the present to stand in the way for the final consummation of any scheme yet broached. It would seem that the most copious supply of water presented in this vicinity is the Little Patuxent River, about four miles distant. To get water from that source would require a reservoir and a pump at the river, besides a long distance to convey the water. The first cost of laying the pipe and the subsequent expense of operating would entail an outlay of money which might prove a chronic burden to the city. The system as suggested by Mr. John F. Kirkwood a year or more since, that of furnishing water to the lower parts of our town by a natural flow from the stream which flows near his residence and to supply the higher parts by means of rams and a reservoir, seems to be

THE SENATE'S TARIFF BILL. enators Brice and Gorman of the Opinio

That the Bill Will Pass. A dispatch from Washington Wednes lay says: Senator Brice, of Ohio, who was the chief mover for the caucus of Democratic Senators, thinks the tariff ll, as reported from the committee, will now pass the Senate, but that the Senate amendments will be materially changed in the House and in conference before necessity of some tariff on coal, iron ore the bill is finally agreed upon. As the bill now stands, he says, it is not satisfactory to all the Democrats of the Senate, and believes that it would be impossible to get such a bill. He thinks it will be debated about two months in the Senate, that there will be some minor changes, but the bill will pass substantially as it now stands. There will be a fight against the income-tax feature and against the abrogation of the reciprocity treaties, but he thinks both will be retained in the bill. There will be enough Republicans, says Mr. Brice, voting with the Democrats, to keep the income tax in the bill. Senator Gorman, of Maryland, said

that he thought, with probably a few small changes, the bill would be likely to pass with the support of all the Democrats of the Senate. He thought that it had now been changed, as he understood it, in such a way as had made it much more satisfactory than it was when it was first presented.

The estimates of the amount of revenue which the tariff bill, as reported to the Senate yesterday, will produce show that the total amount will be about \$331,000,000. This is a reduction of between \$13,000,000 and \$14,000,000 from the estimates on the first bill reported to the committee. The principal reduction is made in the internal revenue part o take a fight as fierce as Armageddon, on the bill through the restoration of the present tax rates on domestic cigars and cigarettes, which amounts to a loss of over \$10,000,000.

There will also be an appreciable falling oil in the duty on tinpiate, caused by changing the duty on that importation There has been a good deal of talk from 11-5 cents to one cent per pound. The change in the fruit schedule, where works question as it is likely to affect are taken from the duitable list will make up the other principal items of loss. Bananas are imported in large quantities, and the imposition of a duty of two cents per pound, as first imposed by the committee, would have produced a revenue of \$1,072,236. The committee found upon investigation, however, that the bill would produce more revenue than would be needed, and as bananas are not produced in this country outside of a small section on the Gulf of Mexico.

it was decided to restore them to the free As the bill stands, if the estimate is correct, it will produce at least \$30,000, 900 more of revenue than will be needed The change made in the sugar schedule will not cause a showing in the revenue estimates different from that made on the sub-committee bill, as the first esti mate was made on sugar testing 90 de grees fine. The estimate for the present bill will probably be upon the same grade of sugar. There would, however, be slight difference in actual returns, as the maximum duty rate under the present bill is 1.381 cents per pound, as against 1.40 cents on the sub-committee bill. The difference on the score would be controlled entirely by the quantity of the




