The Bridge at Elkridge.

There was a joint meeting of the county commissioners of Howard and Baltimore counties Thursday at Elkridge to consider the propriety of lengthening the span of the bridge across the Patapsco near that place now in course of re-erection, a part of which having the recent flood The additional expense necessary was found to be so much larger than they had contemplated that they gave up the idea. The bridge will be placed upon the old piers only about two and onehalf feet higher than before. The bridge if lengthened would have required an additional outlay of about \$3,000, whereas under the present construction the cost will be about \$1,900.

Tuesday's Rain Storm.

The rainstorm of Tuesday night was very severe in different sections of Howard county, and more or less damage is reported to have been occasioned. It was especially in portions of the Third district, where the growing crops were quite badly injured. A barn of Mr. Wm. Whipps, at Oakland Mills, Sixth district, was blown down. On the farms of Mr. Samuel K. George and County Clerk John H. Owings, in the same neighborhood, the wheat was so badly tangled that much of the crop will be unfit for harvesting. State Normal School. During the commencement exercises of the State Normal School Prof. E. B. An average of not less than 70 per cent. in each study, with a general average of not less than 75 per cent., is required for graduation. Of the pro-fessional graduates of '94 all have attained a general average of more than 80 and the majority have made much higher records. The official seal, making the diploma complete, is not affixed until the holder has taught successfully for at least one year. Miss Lena C.
