The tariff bill passed Tuesday by

vote of 39 to 31. The Democrats were solidly in line with the exception of Senator Hill, who voted against the measure after an impassioned speech in opposition to the

Adjournment Tuesday was until Friday.

There is now no reason why the bill should not receive the President's signature during the present month.

THE INCOME TAX.

As some of our readers may not be familiar with the income-tax feature of the pending tariff bill, which is partly responsible for the Baltimore Sun's position of hostility to the measure, we would explain it briefly as follows:

All incomes above \$4,000 are to b taxed two per cent, and the net profits of corporations are to be subjected to a

Of course the great masses of the people, persons of moderate means, are not affect ed, the law applying only to those of wealth and also to great corporate interests.

The Baltimore Sun, being a corporation, will be taxed under the contemplated law \$2,000 on each \$100,000 of its profits. The capitalists and monopolists who own the stock of The Sun will pay at the same rates on Sun dividends swelling their incomes beyond the \$4,000 it is estimated that the burden of taxation imposed upon them will range from ten to twenty thousand dollars per an-

We are not wedded to the income-tax feature of the bill. It is introduced rather as a matter of expediency and not upon any distinct party pledge. For many reasons we might favor its elimination. But the way it stirs up the taxdodgers is a redeeming circumstance. It seems that the party in Congress will not recede from it.

WHAT EVERYBODY SHOULD KNOW. Justice Harlan, of the United States Supreme Court, in his address to the graduates of the University of Maryland law school recently, truly said:

"The man who knows nothing of the form of government under which he lives scarcely deserves to enjoy its benefits."

Justice Harlan further animadverted se verely upon the inexcusable ignorance frequently displayed by lawyers upor he constitution and laws of their coun try, and the curious features of our systems of education under which familiarity may be gained with ancient forms of government to the exclusion of our own to such an extent indeed that presumably educated Americans, visiting Europe, are unable to explain our institutions to the foreigner. Reviewing the conditions under which

the federal constitution was adopted, Justice Harlan spoke of the Virginia Bill of Rights promulgated at Williams burg on June 12, 1776, before the adoption of the constitution, as being aimost as important as the constitution itself. "This bill," he said, "was the work of one man, and to him, to the shame of the American people be it said, no monument has been crected. I allude to George Mason. He wasn't a lawyer, but there was not a word in the bill that was not necessary, and it was the first instrument that declared all men to be by nature equal."

It is no more fair to ascribe a monopoly of legal knowledge to the legal profession that to assume the vesting of all political knowledge in the professional politician. Every good citizen is not exected to practice law, but he should be nevertheless a lawyer to the same extent that he should be a politician although he may never expect to hold public office. A glaving lack in present schemes of public instruction is the failure to prepare the youths of the country for the duties and responsibilities of citizenship. These duties and responsibilities make it imperative that the private citizen should to a certain extent study statecraft, the layman study law.

THE STRIKE.

The strike of railroad employes in the West has assumed proportions quite alarming in that business along more than fifty thousand miles of railroad track has been paralyzed and there is likely to be a conflict between strikers and Federal troops. a pleasant refief to spend a few hours away from Washington, where I have, with a number of gentlemen from other states, been scheming and planning ways and means to assess, to the best of our abilities, to see if we cannot get a sufficient revenue from all your enterprises and even get some of General Agnus income as well, to meet the demands of the nation to carry out just such pro jects as this meeting is called to endorse "I expected to be called upon to committ myself to a bill to take from the Treasury some of these millions that we are trying to put into it to construct this canal. I am much relieved, however, when General Agnus says that the work is to be done by the state and city. That takes us back to the early history of Marland, when, though small and thinly populated, Baltimore was one of the first towns of the Union to petition Congress to give aid to internal improvements. Maryland was the first state to subscribe to a turnpike company, and the Con gressional appropriation for the great National pike was largely due to the petition from Maryland. This state, too was among the first to invest millions in in a canal, and Baltimore and Maryland in what was almost the parent rail "Some say these millions of dollars

were thrown away. I deny it. Every dollar invested by the state and city in these great works brought back three. and Maryland has never had to repudiate a single debt. [Applause.) These facilities aided in keeping Maryland, small as she is, apace with large states. You now have commerce brought from 20 other commonwealths. See what Baltimore village has grown to, and then can you say these millions were

"Balitmore is the only city on the coast that has helped open, its own harbor. This fact had much to do with the su'sequent governmental appropriations. But you cannot stand still. Remember that after you have secured honest money and a fair system of taxation there is no problem before the human mind so great as this one of transportation-this shortening of distances. The country that furnishes the people with the greatest facilities for transportation will be the greatest country on the earth.
"Hence, I say this canal ought to be

puilt. In case of war it would be a great bulwark of protection not only to Baltimore, but to Washington and other great cities on the Atlantic coast. Therefore, t ought to be a national enterprise. Thirteen years ago this subject was brought up at a meeting of your Merchants and Manufacturers' Association. was asked to support it, but with the man I saw I could not do so until the work of deepening your harbor had been Whon that had been done completed. I promised, if still in Congress to do all in my power to aid in building that canal. To-night I renew that pledge." Applause.]

Mr. Gorman then gave a resume of the work being done by Canada to secure inland waterways for huge ships of war. He told of the \$300,000,000 spent by that government to build the Canadian Pacific railway. It was with cheerfulness, there fore, that he had yoted Northwestern states to dig a ship channel in the great lakes along our own shores and to construct a canal to join the waters of the lakes with the Missis-

He assured his Northwestern colleagues that his constituents in Maryland, conservative as they may be, nevertheless beieve in preserving American commerce for the American people. [Applause.] Of the Nicaragua Canal, Mr. Gorman said it would make the United States the mistress of the ocean in 20 years, and would be of greater value than the Suez

Canal. 


