The tariff bill on which Mr. Wilson of the House had so long and unselfishly labored was believed by most Democrats to be a profound economic measure exactly suited to the needs of the country, hence the disappointment when, on reaching the Senate, it was found opposed by a majority.

est cotton mill in the South. Another, for making cotton, wool and worsted yarn, is to occupy a building 110 X 200 feet, which structure alone is to cost \$30,000. "The plans of the new plant," says the Reporter, "have been ready for some time, but it is said the construction of the mill depended upon the settlement of the tariff question." It is located at Philadelphia.

Another cotton mill, with 25,000 spindles, is to be built at Gaffney, S. C.,

with a capital of \$250,000. Another cotton mill, with \$400,000 capital is proposed for Bath, S. C. Two handred thousand dollars have already been subscribed.

The other new mills are for the manufacture of woolen, cotton, knit hosiery. and silk goods. Under the column "Elargement and improvements" there are eighteen men-

tions. Under the column "Starting Up and Shutting Down" twenty mills are mentioned as having started or about to start up. One of these has been closed since April last, another over a year, and a third for two years. All three are woolen mills. Only four are mentioned as shutting down-one to make repairs, another for two weeks, another because of a death, and the last is running on

If this sort of business goes on until November the result of the election may not be so satisfactory to the Republicans as they have been anticipating. They must either manage to keep the mills closed or to keep the backwoods voters from knowing that more wheels are turning than ever before. Can they stave off prosperity until after the election? If the drought had only lasted two months longer Republican prospects would be brighter.

A recent census bulletin shows that 8 per cent. of Kansas farms are owned by the persons cultivating them, and of these farms 55 per cent, are under mortgage. The mortgages aggregate \$73,749,283, or about 36 per cent. of their value. The average rate of interest is over 8 per cent. Each owner o encumbered farm pays upon an average \$92 a year in interest. In Arkansas 95.82 per cent. of farms owned by the occupiers are free of mortgage, and in Alabama 95.65 per cent. Kansas seems to have a pretty heavy burden.

Agricultural Depression.

From the Baltimore Herald. The fact has been chronicled far and wide that farmers in all parts of the country, paticularly in the Western States, have been feeding wheat to hogs. Such use of the great food-stuff cereal produces an unpleasant impression on the mind. Millions of people on the earth are poorly fed. They teem in great cities, they swell the hordes of population in the East and in European countries, and there certainly is call for all the wheat raised on Western farms for the proper feeding of the human race without giving it to swine.

Moreover, the price of cotton and of other farm products has greatly decreasitd since 1870. From tables recently e sued by the Agricultural Department is is learned that the average size of farm in the United States in 1870 was 153 acres, while in 1890 the average acreage was 107; in 1870 also the average selling value per acre was \$56, while in 890 it had been reduced to \$28. In 1867 the average value of an acre of wheat was \$23,05, and it has steadly decreased from that time until now, when it is \$8.35 per acre. In like manner the average value of an acre of corn has steadily gone down from \$18.87 to \$9.09, and similar depreciation in agricultural crop values is noted in oats, rye, barley and buckwheat. The total product of cereals has increased three-fold since 1867, but the value has increased less


