Increasing the Trade.

In a report to the Department of State U. S. Consul Gorman at Matamoras says the effect of the new American tariff is being felt in increased trade with northern Mexico. Large exportations of dressed hides, mules, horses, &c., have been added to the usual exports heretofore made, and the prospects for a large spring business is most cheering. Under the operation of the McKinley act all live stock ceased to be exported, the tariff on horses and mules being \$30 each, from two to three times the selling value of the animals in Mexico. This amounted to a total prohibition, and until September 1 not a live animal of any description has been exported. Large exportations of dressed hides and leather show another new feature that shares benefit of the new schedule.

Something That Is Instructive.

A Mississippi paper publishes a bill of goods purchased by a citizen of that state in 1882, quoting in a parallel column the prices at which the several items can be bought now. The totals-\$39.95 and \$21.89, respectively—show that cotton at five cents a pound in 1894 will purchase quite as much as it would at eleven cents a pound in 1882. There is a good deal that is mighty instructive in this simple statement of a bill of goods containing thirteen items.-Balt. Herald.

Cheaper Living. The New York World, October 15th printed carefully prepared tables showing the reductions in articles of general necessity by comparison of wholesale prices this year and the corresponding time last year. The World says:

"The tables we present to-day show that the cost of living under the Democratic tariff is less by from 10 to 25 per cent. than it was a year ago under the Mckinley tariff. WHEAT.

Hagerstown Mail A farmer writes as follows: Last year the United States exported 117.121,000 bushels of wheat and 16,620,389 barrels of The Japanese have met with some flour. This shows what becomes of a large portion of the wheat crop of this country, and where our people must look for a market. How does the wheat market affect the people?

To begin with, Washington County produces for sale every year about 800. 000 bushels of wheat. At one dollar per bushel this brings into the county \$800, 000 a year. At 50 cents per bushel \$400,-000 less, being a loss of one half. What is the effect of this?

It is very plainly seen upon properly inquiring. Our merchants all over the county sell all the goods they can every day, and nearly all the money taken in they send to the eastern cities for more goods. This is their business and are not censurable for it. But this money must by some neans be brought back again. And how?

Why, mainly by the sale of our wheat Now if we are short in the return of the money every year our county becomes poorer and the people in want of money, just as we find the situation

The next inquiry is, what is the cause The answer is very plain and easily grown all over the world, thereby crushing the market. There is an old adagr, "Too much of anything is good for nothing." So with the wheat crop of the world. No nation buys more wheat than people consume. And the crop

from New York to Liverpool, nearly 3,000 miles, and sell it for 60 cents per bushel. This explains why we have no market. Now, if every farmer's income in this county is only one-half of the usual amounty per year, is it any wonder that he is getting poor? Then, if the farmer is poor who can flourish around him? No one, because the products of the soil is the main spring of our wealth. But, as I have said, over production has brought us to our present deplorable condition in a great measure, and the

The New Army Rifle. Although the standing army of the United States is insignificant compared to those of Europe, the ar Department endeavors to keep it up to the standard in equipment and efficiency. The latest addition to the accourrements is a new small-calibre rifle, generally known as the Krag-Joergensen arm. It was selected after a most thorough test, in which the best American makes, as well as those used by all the European troops, were in competition.

Among the advantages claimed for is greater rapidity in firing, long range, deeper penetrating force of the bullet, and, owing to the use of smokeless powder, less liability to foul. The Springfield rifle has a bore of .45 inches; the Krag-Joergensen of only .30 inches. The cartridges are correspondingly smaller, containing 37 grains of powder and 220 grain nickel-covered bullets, against 70 grains of powder and 405grain bullets for the Springfield musket. This reduction in weight enables the infantry to carry 110 rounds of cartridges instead of 60 rounds, as heretofore.

The effectiveness of the new weapon is also greatly increased. Its initial velocity is 2,000 feet a second against 1, 300 for the old guns, and at thirty yards has been known to penetrate two and ahalf feet of oak. Owing to its flat trajectory a bullet is fatal even at two miles. The old-fashioned bayonet is no longer used, one of knife shape, with handle of steel and wood and metallic scabbard,

haying taken its place. The new rifle should add greatly to the efficiency of the troops. Complaint is being made that the position of the magazine exposes it to injury, that the barrel heats too quickly, and that the sights are inaccurate. But this is denied improved upon and adapted to our service. American smokeless powder will be substituted for the European brand. By way of further innovation, it is suggested that parts of the field equipment, now made of steel, iron or, brass be manufactured of aluminum, which is

much lighter.

Feeding Wheat. The experiments made by Kansas armers this year in the feeding of their surplus wheat to cattle, hogs, and fowls raised for the market have been very successful, according to a report of the Kansas Board of Agriculture. It is more profitable for them to use their wheat thus than to sell it at the prevailing low prices, which are not likely to advance soon to the desirable notch of a dollar




