Many were assaulted to death, and the remainder dispatched with the sword. Other women were carried off to Moslem harems or slaughtered on refusing to go. Children were placed in line, apparently to see how many could be killed with one bullet. Many were beheaded Estimates vary from 3000 to 8000 as to the number massacred. Some estimates place the number twice as high."

JAPAN A FIRST CLASS POWER.

Her Position in the Sisterhood of Nations is Recognized. The new treaty between the United States and Japan has excited consider-

able comment in diplomatic and official circles at Washington. The full text of the treaty when it appeared was scanned with the greatest interest as it was the first opportunity to get at the exact details of an instrument which formally recognizes Japan as a firstclass power in the sisterhood of nations.

The treaty shows how fully the United States has accorded Japan the recognition she has now as an enlightened, modern nation. All previous treaties have been based on the theory that the relics of Eastern barbarism remained with Japan. Accordingly she was not allowed to conduct her own courts or to make her own tariff laws, but special treaty regulations were made to protect American litigants and American commerce in Japan on the presumption that the native laws would not afford adequate protection. Running throughout the new treaty are the concessions recognizing her courts and laws as ample for Americans as well as natives. This is the chief feature of the treaty. The right of Japan to make her own tariff laws is also recognized. Heretofore the United States has been free to nake such tariff laws as she saw fit affecting Japan, but the latter was forbidden by treaty from fixing duties above 6 per cent, ad valorem. The protocol of the new treaty recognizes the general statutory laws of Japan concerning the tariff, and give her for the first time the "favored nation clause," by which she is guaranteed against any higher duties than those the United States imposes on other countries. The abolition of the foreign settlements, and their absor

tion by the native cantons of Japan another recognition of her advanc municipal organization. On the other hand, the United State secures many substantial advantages. The missionaries, who make up such a very large class in Japan, are guaranteed freedom of worship and protection in that worship. The main concession, however, is that by which Japan is opened up to American commerce. Heretofore Americans have been restricted to a few treaty ports of Japan. They could not reside, or carry on business, or even travel in the interior Now, however, every corner of the country is opened to Americans. They can establish business and maufactures, lease lands, etc. It is favor of the Back Creek route, which is and commerce. ected to our alien labor and immigration laws. The provision of the treaty that it must be ratified within six months makes it incumbent for the Senate to act on it at the present session or the will fail. There is every probability, however, that the Serate will act promptly. Minister Kurino has forwarded a copy of the treaty to his goverment, where it will be considered by the privy council of Japan.

The two civilized nations which will have the greatest power will be the United States and Russia, having together over 700,000,000 inhabitants.

AN ENORMOUS TOTAL. Deaths From Wild Animals and Snakes in British Medical Journal: The official returns for 1893 show that 21,213 human beings were killed in India by snakes, an increase of 2188 on 1892; and 5122 cattle. an increase of 624 on 1892; by wild beasts -meaning thereby tigers, leopards, wolves, bears, hyenas, etc.-2804 human beings were killed, a decrease of 159 on 1892, and 85,131 cattle, an increase of 7961 on 1892. The number of wild beasts destroyed was 15,309, a decrease of 679 on 1892; the number of snakes destroyed was 117,120, an increase of 32,331 on 1892. 


