THE CASE OF DR. J. W. HEBB. Proceedings Under the Vaccination Indict

In the Circuit Court of Frederick county, Wednesday the removed case of Dr. J. W. Hebb, of the Howard county School Board, was taken up on a demurrer to the indictment charging Dr. Hebb with receiving \$50 in excess of the salary of \$100 per year allowed him as a memmember of the school board. The indictment against Dr. Hebb, as is wellknown, was found by the September grand jury in Howard county. In the trial of the case Thursday the state was represented by State's Attorney Fdward S. Eichelberger, of Frederick, and State's Attorney Joseph D. Mcguire, of Howard county. John C. Motter, of Frederick; Edgar H. Gans and Charles K. Dorsey opened for the defendant. The indictment was read, and arguments heard by the court, which sustained the demurrer and pronounced the indictment defective. A second indictment against Dr. Hebb, for receiving \$600 in excess of the legal fee for vaccinating school children, was called in the after-

The court, in sustaining the demurrer to the first indictment, took the ground that the bill failed to specify he date the alleged excess was received, and also that there were two charges made in one count, the excess payment of \$50 having been drawn in two seperate amounts. On the second indiciment Dr. Hebb asked for a jury trial A jury was impaneled without much trouble, and the case was opened for the state by Mr Eichelberger. Court adjourned at three o'clock for an hour, and upon reassemb ling, the state put on the stand ex-School Commissioner Hardey, County Commissioner Owings and ex-Treasurer John Emory Hill, to prove the payment to Dr. Hebb of the \$600 excess for vaccination fees. Counsel for the defense objected to all the testimony, on the ground that it did not prove the specified charges in the incictment. They contended that Dr. Hebb could not be guilty of any crime in drawing money due to him as a physicien; that if there was any crime, it was on the part of the achool board in ordering the payment of the money. The court overruled the objection, without stating the ground for its ruling, and the defense noted an exception. The state then closed its case, court adjourning until Friday, when the case will be taken up for the defense Judges McSherry, Lynch and Vinson are on the bench.

FLORENCE, Dec. 12 -- It decurs to the writer that it is proper for the little village of Florence to be heard from more frequently through the medium of the local columns of your valuable paper. With your permission, Mr. Editor, your correspondent will in a brief way, and for the special benefit of your readers, who are in ignorance as to the exact situation of Florence, give a description of the same. Florence is located on the eastern slope of Parr's Ridge, four and one-half miles from Woodbine, and on the road leading from Lisbon to Laytonsville, Montgomery county.

This neighborhood was some twenty or thirty years ago, commonly known as "The Barrens," but now is one of the prettiest sections of Howard, as well as splendid farming and grazing region. 


