Value of Wheat for Feed. Morton, in reference to feeding wheat to

"Wheat value as an animal food carefully and with due regard to the habits and environments of the animals and the forage feed accompanying it. Growing or fattening animals are found to

thrive upon it. "The profit in feeding wheat, when that cereal and corn are at the same price, is greater than in feeding the latter. Wheat weighs seven per cent. heavier than corn. Wheat is weight for weight, equally good for fattening animals, and better for growing animals. "The South Dakota Experiment Sta-

tion has made a very comprehensive and exhaustive experiment in feeding ground wheat to hogs. The pork from that feeding is pronounced superior to any other. The feeding should be begun by giving very small quantities to the animal It should be mixed with chopped hay or with other grain. The department will furnish leaflets upon the subject to all country newspapers. The B. and O.'s great tunnel under John Love, alias Charles Johnson, two Baltimore as an engineering feat is attracting the attention of the country. > The first traffic train over the new line was started from Camden Station at 10.46 o'clock Friday morning of last week. It was a fast freight for Philadelphia and New York, and made the trip over the seven miles of the new road in good time. The train was made up of seventeen cars, loaded with miscellaneous freight. It was in charge of Fred. Ruppatt as conductor, and J. Snyder handled the throttle of the locomotive which pulled it. The locomotive was No. 1399. The train was made up on the Belt Road tracks in the open cut near Henrietta street. The heavy train moved off easily and

as it entered the south portal of the tunnel those on board gave a cheer as being the first to travel as passengers and guests through this magnificent work. The locomotive moved slowly, as the track was newly laid and not fully ballasted. It was also desired by the engineers to "set" the heavy steel rails

to the ties. The tunnel for the most part was in total darkness. Occasionally a flare of light was seen and as the train flitted by the engineers would cry out, "Now we are at Baltimore street," "This is Franklin street" or "Here we are under Preston street," indicating that section hands were at work at these points in the

It was exactly ten minutes after the time when the train entered the south end of the tunnel that it emerged from paration. the north end in the Bolton lot. There it was stopped while the Baltimore and Onio officers got out and inspected the tunnel and roadbed. After some delay at this point and at North avenue the train pushed on and in an hour and fifty minutes from the time it started it was on the main line at Bayview Junction.
