HENSON LYNCHED.

HE IS SUMMÁRILY TÁKEN FROM JÁI AND HANGED.

Masked Men Do the Work-The Doome man Appeals for Mercy, But as He Showed none Himself He is Hurried to Tree-The Work Done at Midnight Quietly, Surely and Swiftly--No Excitement Afterwards-Full Details.

Jacob Henson, Jr., confined in the jail here for the murder of Daniel F. Shea, between the hours of 12 and 1 o'clock Monday night last was taken from the jail by persons unknown and hanged to a tree near the residence of Hon. Reuben D. Johnson, on Merrick Avenue.

It had been more than hinted that there would be no miscarriage of justice in Henson's case. The entire community was of the opinion that he richly deserved the extreme penalty of the law, and the recent attempt on the part of the tion of his sentence to imprisonment for life on the ground that he was weakand we have the end - naturally enough under the circumstances.

The affair was carried through with day morning. It is generally believed that the lynching party, all of whom wore masks, and were well armed, were citizens of Ellicott City. Since the question of Henson's sanity has been raised several physicians have visited the jail and examined the prisoner. On Monday another delegation, consisting of Drs. L. G. Smart, of the Sheppard Asylum; Chas. G. Hill, of Mount Hope, and R. W. Dashiell and William Lee, members of the State Lunacy Commission were sent here by Governor Brown to examine the prisoner. They made report of their examination to the Governor Tuesday to the effect that Henson was responsible. The citizens, however, could not foresee this, and they feared that the execution would not take place at the appointed time, and the lynchers, it is supposed, came to the conclusion that they would take time by the forelock, and make sure that Henson suffer

The plans were laid in the quietest manner, and when the people of Ellicott City went to their repose on Monday night, they little-realized that Henson would be a dead man before daylight Not the slightest apprehension was felt at the jail, which was in charge of Deputy Warden Robert H. Holtman, in the absence of Warden John J. Lilly, who was at Wheeling, W. Va., attending a court case. To reach the jail corridor from the house the lynchers had to pass a heavy iron door, but this was soon opened after the lock had been knocked off with an ax. Beyond this was a frail wooden door, which soon gave away to to the lynchers. Wicks, who had been in the corridor of the jail, heard the men approaching, and became so badly frightened that he crept in a cell that had been fitted up as a library, and hid himself under some furniture. From his room Deputy Holtman heard the determined men knock the lock off the cell occupied by Henson, and heard the poor, frembling wretch yell; "Lord, have mercy upon me." This he repeated three times, while the men were getting him into a shirt and a pair of trousers, and incidently placing a rope of half inch hemp around his neck, which was tied in a regular hangman's noose. This operation took but a few minutes, and, without further ceremony, Henson was dragged, groaning and appealing for mercy, through the jail corridor, then through the house, and out into the back yard. In the meantime consternation was reigning on the second floor of the household, where I buty Holtman and the ladies of the ho. were. The ladies had become greatly agitated, and their fear became more intense when they thought that the lynchers would execute Henson in the yard of the house. They screamed to the lynchers, who appeared to be about twenty in number, to take Monday next. As this course is in the the man avay, and the lynchers lost no time in doing se. When Henson was taken from his cell he was dressed in a cotton shirt, a pair of trousers and a pair of shoes. At the brow of the hill he lost one of his shoes, which was found some time after the lynching hul been discovered. On their way they found one of Henson's shoes, and two masks, that were made of some light fabrie, like muslin. Henson's feet were within a short distance of the ground, and he was not only dead, but his body was cold and rigid. Chief Vansant immediately went back to the town, and summoned a jury of inquest, with Gerhardt Butke as foreman. A PAPER MILL ABLAZE.

A considerable portion of the Mentzel Paper Company's works on Sucker Branch, a short distance west of Ellicott Patapsco, was destroyed by fire Monday morning. The fire, which originated in the storage warehouse back of the main building, was discovered about half past five o'clock and a messenger was despatched here to notify the fire department. The fire company hastily responded, but by the time the apparatus could be gotten on the scene the flames, which were fed by the combustible material stored on the floor, had enveloped almost the entire upper part of the building. The progress of the fire, however, had heen checked somewhat by a number of the employes of the mill and residents from the Baltimore county side. Soon after the engine began to play on the burning mass the fire was gotten under the machinery rooms and extensive front structures. The burnt portion contained, besides a thousand or more dollars' worth of raw material, some valuable machinery, included among which was a new rag cutter, which had only recently been supplied. The loss altogether will reach in the neighborhood of \$5,000, and is partly covered by insurance. The origin of the fire is somewhat of a mystery. It is believed, however, to have

been the result of spontaneous combustion, started among the rags. The watchman left the mill at twelve o'clock at which time the works were inspected and everything found all right. This is the second fire of an unaccountable na-

ture that has occurred at the mill within a short time. Too much praise cannot be accorded o our fire department, who, with commendable energy and hard work, succeded in keeping the flames confined to the one building, thus saving probably \$20,000 worth of property. The entire


