Wholesale Thieving.

Notwithstanding the unusual precautions that have been exercised by the farmers in this vicinity to suppress the systematic robbing of their henneries, the thefts of poultry are still of frequent occurrence. A few nights ago the henhouse of Mr. John W. McKenzie, near this place, was broken into and sixtythree chickens carried off. Mr. Thomas M. Johnson, of the same neighborhood, had stolen from him about two hundred, many of them being choice breeds. Mr. William Miller, living near Ellicott City. also had thirteen fine hens stolen from his hen-house one night this week, and a calf was carried away from the barnyard of an adjoining farmer by the depredators. So enraged have the farmers become at these frequent raids on their property that the pilferers, if caught, will likely be harshly dealt with.

In the genial atmosphere of academical studies and associations, his natural desire for knowledge grew into a taste for literature and science; and there arose on his youthful mind an ambiand there arose in lis youthful mind an ambi-tion to enter the ranks of professional men-Hence he did not remain "on the farm" long, but began professional life, like so many thousands had done before, by employing his knowledge and skill in helping others to gain an education. He first realized at Beaver Creek school house, in Washington county, Md., the poet's assertion:

There is a tide in the affairs of men which "There is a tide in the anairs of men which taken at the flood leads on to fortune," is the poetic expression of a truth universally acknowledged, namely: that success in life is attainable by one who uses his opportunities. dence that the discovery of the nucleus tainable by one who uses his opportunities. It is equally true that one's own fastes, if followed, will lead him into that vocation for which his talents ift him. Where tastes are various, the strongest should be followed, and the others should be made tributary. When one in the midst of mature years and active labors in a chosen profession, suddenly steps into another vocation, he is regarded as vacillating; or else is pronounced the happy tempient of a special light from some source thrown upon his pathway. Following the guide of his tastes and treasuring as vatuable acquirement what he had learned of the law, he entered upon the study of medicine at the age of a comet on the disk of the sun by one among his conferees, and for years enthusias among his conferces, and for years enthusias-tically and successfully practised in that gen-iat and appreciative community. In 1872 an attack of typhoid fever, with its consequent loss of vitality; confined him to the house for nearly a year. The wisdom of his choice of profession was seen wisdom of his choice of profession was seen not only in his success in the healing art among the people generally but also in the skill with which he managed his own life-long battle with heart disease, and triumphantly led the enfeebled life forces of his invalid wite through a long war with allied diseases, compassing campaigns of vigorous resistance, bold attack, and masterly retreat, until finally he to gain better health.
