ANOTHER PLAN FOR THE ROADS.

Meeting in Baltimore-The Ground Care fully Looked Over. The sub-committee of the legislative committee appointed by the recent Good

Roads Convention at Annapolls has prethe Ways and Means Committee of the House, providing that the State Geological Survey Commission shall investigate Legislature in detail. The committee meeting lasted from ten in the morning until nearly three in the afternoon. There were present twelve men tepre-senting all sections of the state, and many varied interests. As a result of the meeting, it was agreed to bend all efforts to the passing a bill providing for roads by the state geological survey. This survey, of which Prof. William Bullock Clarke, of Johns Hopkins Univestigate the roads of every section of the state. It is to make a minute report, showing the present condition of these roads, together with plans for their improvements, estimates of cost and suggestions of the materials and methods ecessary to secure good roads. This report is to cover two years, and is to be ubmitted at the next session of the egislature. The cost of the work will e about \$15,000, and all those at the above meeting enthusiastically agreed that it would be the best \$15,000 ever pent in Maryland, if the object sought

s achieved. Pursuant to this agreement among the committee, all other road bills at Annapolis will be abandonded and efforts concentrated to the passage of the geo-

non and Conway Sams were appointed a committee to draw up bills looking to some immediate remedy in the condition of the roads. This bill will provide for the establishment of stone crushers in various sections of the state and for the Issuance of county bonds for the purpose of road improvements. These bonds are to be sold for not less than par at a rate of interest of three and one-half per cent. Before being issued the county cominis sioners are to submit to a vote of the county the proposition for the bond is sue; but the question is not to be put to a vote until a petition has been received by the commissioners, signed by at least 200 bona fide residents of the coun-

ty in question, who are taxpayers on at

least \$500 worth of property.

principally by colored men and non-tax-It was contended that Howard county was not favorable to creating a debt for road improvements, such as is contemplated by Senator Day's bill, and that the county commissioners of Howard county could invest the money to far greater ad vantage than the road commission named

in the bill. Mr. W. S. Powell, president of the Hy attaville Farmera' Club; ex-State Senator John G. Rogers, Reuben D. Johnson counsel to the board of Howard county commissioners, and Joshua N. Warfield posed the bill.

There were several lively tilts between Senator Day and several gentlemen from his own county. Mr. Rogers claimed the bill was intended for political effect, and others in the delegation said the Senator from Howard had actively pushed forward the measure when he knew the people of the county were opposed to taking internal


