WORD FROM GOTTLEIB SCHNEIDER. He Killed a Man at Sheep Camp But Was Done in Belf Defence-Tried

and Acquitted.

EDITOR TIMES: As I read some account in your pape of March 26, about Gottlieb Schneider. now in Alaska, I thought I would, ac cording to news received from him in his own hand writing, dated Sheep Camp. March 20, 1898, make some corrections and give you a further statement in re-gard to the alleged murder committed by

him at the above mentioned place.

First of all Mr. Schneider stated in letter, dated March 7, written at Dyea, all about the hardships a man has to go through from Dyea to the gold fields. He said amongst other things that there is a mountain 1180 feet high which must be climbed, almost straight up, as there are steps cut in the snow and a rope to hold yourself by. A man has to convey all packages on his back and is not allowed more than 100 lbs. at one time. So, lo get everything up the trip has to be about one hundred men returned from there unable to get up the mountain.

It was at this point that a man approached Schneider and offered to go up with him and they would go together so that the journey would be easier; said his old partner had returned owing to being unable to make the summit of the pass. Schneider told him as he was not fully prepared, caused by lack of money, and that the U.S. authorities would not allow anybody to go up without the necessary food and utensils, he would have to wait until he could earn or get some money from the east. 
