PEACE IN SIGHT.

The progress of events looking to peace culminated on Wednesday and may be summoned up as follows:

First-President McKinley sends to Spain reiteration of the original demands of the United States, which is, in effect, an ultimatum. Spain must reply within 48 hours. It is believed that she will accept the terms, owing to the failure of her last message to cause the United States to recede from its position. Second-Secretary of State Day and Ambassador Cambon agree on the terms of this message, which are:

(a) The immediate evacuation of Cuba by Spanish troops, and the relinquishment sovereignty over that island by Spain. (b) The immediate evacuation of Porto Ric and all the Spanish islands in the Caribbean Sea by Spain, and their cession to the United (e) The United States to occupy and hold

the Harbor and City of Manina and Subic Bay until a peace commission determines the rights of both Spain and the United States in the Philippines (d) The cession of an island in the Ladron group, the island not being specifically named, Third-The War Department issued orders today for the immediate sailing of 10,000 troops

from San Francisco to reinforce General Mer ritt at Manila. Fourth-The Navy Department announces that if Spain does not accept the ultimatum within the specified time the Eastern Squadron would be dispatched to attack the Coast

A dispatch this (Friday) morning from Madrid states that Ambassador Cambon would be directed to sign the protocol at

If proof were needed that Mr. McKinley made a serious mistake in not definitely naming all the terms of peace that Spain must accept, instead of leaving some of them to be settled by a joint commission, it was furnished in chunks by Spain's first answer, accepting the terms of peace, but on condition that numerous things, including whether Cuba should be responsible for a portion of the Spanish bonded debt, should be determined by the Peace Commission. That it was compelled to waive the conditions and accept the terms of peace without conditions, does not lessen the mistake Mr. McKinley made in leaving anything to be settled by commission, as the country will realize long before that commission completes its work. Spain was whipped to her knees and was bound to accept any terms of peace Mr. McKinley chose to offer and there was not a single good reason why settled the whole business for good and all. The excuse for not doing that is not a valid one. It is that the administration had not decided what should be done with the Philippines. The people have decided that Spanish rule ought not to be continued in any part of the Philippines, if the administration hasn't.

A BATTLE AT MANILA.

Advices reached here Wednesday giving the details of a terrible sortie by the Spaniards at Manila on the night of July 31, they having attacked the American camp between Manila and Cavite. It is taken, with heavy losses. The Spaniards, 3,000 strong, made several desperate charges, but were repeatedly repulsed, their centre being finally broken and the enemy retreating They subsequently rallied, however, and made a second attack, and this time the Spaniards were driven back in great disorder, the American victory being complete. The American losses were 11 men killed and 37 wounded, while the Spanish casualties are roughly estimated at about 200 killed and 300 wounded.

A typhoon was raging at the time, and the Spanish attack began during a heavy downpour of rain, the evident object of the enemy being to surprise the American camp. It appears that they succeeded in driving in our pickets, but were

checked at the trenches. For several days General Greene, with a force of 4,000 men, had been advancing upon Manila and throwing up breastrorks at intervals, and the object of the attack was to prevent a further advance The insurgents took no part in the battle. After the assault General Greene issued an address to his soldiers commending them for their conspicuous display of courage in the face of a galling fire, and for their success in repelling the attack.

REVIEW OF THE WAR.

We Sunk \$26,000,000 in War Ships-Few est Killed in History-Significant tha our First Capture was a Spanish Prize Called "Good Venture." The greatest events of the century as regards the future power of the United States among the nations of the world

The army has increased to 278,500 men, inregiments. Twenty-five Spanish war ships, valued at \$26,400,000, have been destroyed without the loss of an American ship.

OUR FIRST PRIZE "GOOD VENTURE" The first shot of the Spanish-American war was fired on April 22, when the gunboat Nashville brought the Spanish merchantman Buena Ventura (Good Venture) to time. It was on the day after Presitent McKinley ordered the Key West fleet to proceed to Cuba. On the following day the President issued a call for 125,000 yulenteers, and on April 24 Spain

Hostnities had actually been in progress two days before the declaration was made. There had been briefer wars in history, but it is doubtful if there has been one in which the loss of life was less, considering the length of hostilities. SPAIN'S LOSS SEVEN TIMES OURS.

The figures show that 266 Americans vere killed in battle with 1400 wounded. The Spanish losses were 2000 killed and 2630 wounded. Those who have died since as the result of wounds or pestilence are not included. Dewey, with orders to capture or de-

stroy the Spanish fleet in the Philippines, set sail from Hong Kong April 24-the day war was declared by Spain. On the following day, the Spanish forts opened fire upon the American fleet off Havana. THE DECLARATION OF WAR.

DEWEY'S BRILLIANT VICTORY. Events came rapidly, and on May 1 Dewey destroyed the Spanish fleet of 11 war ships in the Bay of Manila and subsequently took possession of Cavite. The Cape Verde fleet was reported at Santiago May 19, the day after the safe arrival of the Oregon was announced The President called for 75,000 additional troops on May 25. On the same day the first expedition of 6000 men left San Francisco for Manila, and Sampson ppened upon the fortifications of Santi-

On June 3 Lieutenant Hobson, with seven volunteers, sank the Merrimac in time in the nether world, does not necesthe entrance to Santiago harbor, one of the thrilling acts of the war. Six hundred American marines landed at Guantanamo Bay, June 10, and were

attacked the following day, with a loss o four killed and several wounded. The second expedition to Manila sailed June 15, and the Vesuvious then first threw dynamite shells into Santiago. The Cai manero forts were reduced on the follow ing day.

SHAFTER'S CAMPAIGN General Shafter's troops arrived of Santiago June 21 and landed at Sibonev June 23. On June 24, 16 Americans were killed, including six of Roosevelt's Rough Riders, and 50 more were wound ed in driving the Spanish back toward Santiago. Two days later General Shafter occupied Seville, and on June 30 he

had 13,000 troops in front of Santiago. The assault upon Santiago began July 1, when El Caney and San Juan were

HAWAH AND BANTIAGO IN ONE DAY. The President signed the resolutions for the annexation of Hawaii, and General Toral surrendered Santiago City July 14. On July 17 the American flag was raised over the city. General Miles and the Porto Rico ex-

pedition began landing on July 25, and on the following day Spain formally sued for peace through the French Ambassa-The city of Ponce, Porto Rico, surrended to General Miles July 28. The President named the conditions under which peace would be discussed, which was made public on August 2, and Saturday last it was announced that his terms had been accepted by the Queen Regent of Spain.
