The cars, which will be heated in winter time with electricity, will be convertible, that is, can be turned into summer cars with open sides. One of the conveniences will be an electric button, to be pressed when a passenger desires to have the car stop. It is said a partial express will be introduced. It is not fully known but the frequent surveying on this side of the Patapsco indicates strongly that it is the intention of the company to run at least one track up Main street of our village, to a point not yet determined upon. This track if built will run along the north side of the street in order to give as much room as possible on the other side for vehicles,

It was stated by a gentleman a few days ago, in a position to know, that It is the intention of the Consolidated company to arch the huge, unsightly cut which now disfigures the scenery across the river. A prominent contractor said this cut should never had been made, that a mistake was committeed in not crossing the river and running parallel with Tiber branch, south of Main street, coming out on to the turnpike at the west end. The contractors, Messrs. David E. Evans & Co., say that the cars ought to be running before the holidays.
