BLECTRIC RAILWAYS IN HOWARD.

Dur County Presenting an Inviting Field for Cross Lines. As electric railways are as inevitable as turnpikes were seventy-five or more

years ago, it is not unreasonable to suppose that counties favorably situated with sufficient populations, will be gridironed with them ere long. Howard county is all that could be desired in this respect, and must eventually attract the attention of capitalists. Any one taking the trouble to consult the map will at once see that a line from Sykesville to Laurel is an urgent necessity. It would form almost a direct line to Washington. But such a line would be very incomplete without a line from Ellicott City to Rockville. It would make a system that could not help but pay, besides opening up some of the most desirable sections of Maryland. An electric line leaving Ellicott City for Rockville by veering a little to the northwest would go near St. Charles' College and cross almost at right angles the Laurel-Sykesville line at a point near Clarksville. These lines once completed, a large amount of untraversed territory would be brought in quick communication with Baltimore, Washington and a number of other important points. Farmers and others could do a good deal toward encouraging such an enterprise by offering rights of way, &c. Property along the lines would increase in value

not less than ten per cent., and farmers could afford to assist a company undertaking the work very materially and An advantage not to be overlooked would be the distribution of power among the farmers. For a distance of at least five miles on either side of the tracks electricity could be used for all purposes of the farm requiring power, such as threshing, sawing, grinding, &c., to be turned on during any hour of the day. Country homes also would be

modernized by the use of electric lights. Would such a system pay? Let us see The distance from Sykesyille to Laurel is 20 miles; from Ellicott City to Rockville about 30 miles-50 miles in all. I is estimated that electric railways over routes fairly favorable as regards topographical features, can be put down a the cost of \$5,000 per mile. This would involve an expense of \$250,000 for the 50 miles. It is estimated that the power houses and other necessary appurtenan ces would cost \$200,000 more, making total cost of the two lines \$450,000. It would be difficult to approximate the possible business that would accrue from such a system. It is reasonable to be lieve that it would increase from year to year. Would not the operating expenses over run the receipts? would naturally be the query of the capitalist. Why should it? Upon each of these occasions that body was composed exclusively of members of the democratic party. In 1572 he became a candidate for the office of State treasurer, but was defeated in caucus by Hon. John Davis, of Baltimore. In March of the same vary he was expensed to these of the same year he was appointed tobaccoinspector by Gov. William Pinkney Whyte and served two years in that office. TREASURER AND CONGRESSMAN.

TREASURER AND CONGRESSMAN.

In 1874 he was elected State treasurer for two years, and was re-elected five times by five successive Legislatures. He served in this office for eleven years and two months, resigning in his sixth term to go into the Forty-minth Congress, to which he was elected in the fifth district of Maryland. He was re-elected to the Fiftieth Congress and to the Fifty-first Congress in 1890. This was the first Reed Congress of force-bill fame. Mr. Compton's seat was contested by Mr. Sydney E. Mudd and he was unseated, although his plurality over Mudd was 1,618. Mr. Compton appealed to the people at the next congressional election in 1892, and was returned by an increased plurality. This time his opponent was Mr. Thomas Parran, of Calvert county. Before the expiration of this term he resigned to accept the place of naval officer of Baltimore City, to which he was appointed by Mr. Cleveland in 1894. This was the last office he held. He filled out the full term of four years and went out last May, six months before his death. After leaving this office he at once engaged in private business in Baltimore, going to his home in Laurel each evening. For some months his health was far from robust and a number of weeks ago he took to his bed.

He was always present when his health permitted at the monthly meetings of the board.
