SENATOR GORMAN'S GREAT SPEECH. Spanish-American Treaty Under Consideration-Earnest Words From a Retiring Senator.

In the open Senate debate upon the Spanish-American Treaty, Monday, 6th, Senator Gorman made what may possibly be his last public important utterance in the Senate during the closing hours of his term there.

It was the finale of the debate on the treaty, and came in the nature of a surprise to the members on both sides of the question, who had not the slightest intimation that the Senator would speak. It was the terminating effort on the

part of those opposed to the ratification of the treaty. As Mr. Gorman ceased, the Senate went into executive session, and a vote was taken and the treaty ratified by 1 majority. So he, who had led the fight against the

MR. GORMAN'S SPEECH.

Mr. Gorman said: Mr. President, I have not consumed any time of the Senate in the discussion of the resolutions that are pending. have had no intention to do so and would not now but for the occurrences of the last two days in this chamber. The remarks of the distinguished Senator from Nebraska (Mr. Allen,) who addressed the Senate this morning, in connection with the remarks made by the distinguished Senator from Colorado Mr. Wolcott), seem to make it necessary that I should say one word before we shall have entered upon the real consideration of the treaty in secret sesson.

It has grown to be an unfortunate custom, Mr. President, that the newspaper criticisms of the public men find eady conduits in this body, so that the utterances made may be recorded here upon our records. No matter how severe the criticisms, how unjust the comment, it seems that at times they are to find their way into this body and to be repeated by honorable members of the

My attitude upon his treaty was wel defined in public utterances before the treaty was negotiated, so far as it refers to the acquisition of the Philippine Islands. My opinion upon that question was well known and freely expressed by me to one of the Commissioners who negotiated the treaty before he left this country for Paris. I have had no cause to change the opinions then expressed publicly and privately. They were opinions formed after nature deliberation; opinions that I believed were in the best interests of my country; opinions to be maintained by me, no matter what the influence may be upon the other

In my course in public life, Mr. President. Presidents of the United States and their Cabinets have had no terrors for me. have opposed them when they were of my own political faith because I believed that they were too extreme and would put in jeopardy the business interests of the American people. Mr. President, away beyond office, away beyond personal desire of promotion of any sort, stands the great question which we are facing. Yesterday, Sunday as it was, the cable flashed the news that, because of the attitude of the American Republic in their determination, in their effort, in their threat to take possession of a people who did not desire to become a part of the nation, the blood of American citizens had flowed. Those natives, fighting for their liberty, as they understand it, made an attack upon the American Navy and the Ameri-

Who, Mr. President, believes for moment that if there was a provision in the pending treaty like that which relates to Cuba, that our occupation would be only temporary, that it was only intended to aid them to form a better government, to control their own affairs, there would have been a single life lost? CHINESE EXCLUSION. Do you remember, Mr. President-Ido -that it was but eight years ago, with this great American nation in all its lining up in the Presidential battle of 1888, when the working people, the men who are engaged in trades, the men who power, with two great political parties are engaged in labor, rose up and were so strong that they compelled both political parties to abrogate a treaty with China which admitted the Chinese to come in, a few hundred thousand, on the Pacific coast; and that was done right in the face of a Presidential election?

I think the most disgraceful chapter in the history of the country since I have been familiar with it then took place. I am glad to say that I denounced it then. While we were negotiating with China, a friendly nation, with whom we were at peace, for a modification of the treaty negotiated by Mr. Seward in 1868, both parties were absolutely driven, so powerful was the feeling of the laboring people of the country, to pass an act of Congress abrogating the treaty without giving the friendly nation an opportunity for consideration.

We made that restriction and destroyed our trade with China. They submitted to it as no other nation on the earth would have submitted to it. Our trade melted away until it has run down to almost to nothing, compared with that of Great Britain, France and Germany. And now, eight years after that act, we propose to take islands that are in front of the China Sea. No nation of earth could guard them. No power is strong enough to prevent the Chinese from coming over and getting in, and it is a
