A FEARFUL AFTERMATH. General Miles, commander-in-chief of the army and the one military officer in the West Indian campaign who has never been accused of a military mistake, gets as his reward a floodtide of venomous accusations from treacherous accusers and is today practically on trial before a military tribunal for having told the

truth about the endangered health of the army by fraudulent contractors. Admiral Dewey, who won the first great battle of the war and one unexampled in naval history, is yet without the honor of Admiral that the country as with one voice has demanded for him. His promotion has been hindered by the juggling of naval pretenders who want the rank of Vice Admiral for a man who never fought a battle in the war, and who is most conspicuous in seeking to rob another of his just honors for the naval victory at Santiago.

Admiral Schley, who was formally charged with command of the fleet at Santiago by Admiral Sampson on the morning of July 3d, and under whose command the entire Spanish squardron was destroyed, is accused to-day of in competency or cowardice to aid in the unjust promotion of Admiral Sampson, and his pay has been reduced \$2,000 a year by his retirement from service at

Captain Clark, whose achievement in the great cruise of the Oregon from San Francisco to Key West will be always famous in naval history, and whose vessel under his command was the most potent of all in destroying the Spanish fleet at Santiago, is reduced in pay \$1,700 a year by assignment to shore duty.

General Eagan, who was No. 68 on the list of Lieutenant Colonels at the beginning of the war, who was promoted to a Brigadier Generalship by favoritism and in his efforts to reward the favoritism that promoted him exhibited the most flagrant blackguardism and was dishonorably dismissed from the service by a military court, has been relieved of his sentence and given full pay in idleness for six vears.

Adjutant General Corbin, who by like favoritism was promoted from No. 44 on the list of Colonels to a Brigadler Generalship and given the highest position under the Secretary of War, and who when General Miles was ordered to Santiago, telegraphed General Shafter not to obey him, is now seeking to be made a Major General by act of Congress.

By this means each had a valentine; but the men stuck faster to the valentine that had fallen to him than to the yalentine to whom he had fallen. Fortune having divided the company into so many couples, the valentines gave treats to their mistresses, wore their billets several days upon their bosoms or sleeves, the whole proceeding in a little sport which was enjoyed by all who believed it would eventually end in love. It was merely a pastime of that remote period when ridiculous missives of any kind were unknown. If missives were exchanged at all, they contained only a courteous profession of attachment from some young man to some young maiden, honeyed with a few compliments to her various perfections, and expressive of a hope that his affections might meet with a return. The origin of the peculiar observances of St. Valentine's Day is subject to great obscurity. The Saint himself being a priest of Rome, and martyred in the third century, seems to have had nothing to do with the matter beyond the accident of his day being used for the purpose. It was the practice in ancient Rome, commencing on the 14th of February, to celebrate the Lu percalia, which were feasts in honor of Pan and Juno, whence the latter deity was named Ferbruata, Ferbrualis, and Ferbrulla. On this occasion, amidst a variety of ceremonies, the names of young women were put in a box, from which they were drawn by young men as chance directed. The day is now almost everywhere, a much degenerated festival, the only observance of any note consisting merely in sending jocular anonymous missives to parties whom one wishes to quiz, and this is confined


