Up to within a short time before the blockade by American vessels the Spanish Govern-Cuba fairly well paid, and the army was not over four or five months behind in receiving its pay. It would, therefore, appear that Weyler and his combination got away with nearly \$8,000,000 from the padded army payroll.

The report that the Attorney General of the U.S., was about to begin proceedings against the Standard Oil Company for violating the Anti-Trust law was too good to be true. There is no doubt that the Standard Oil trust and a score of others are constantly violating the Anti-Trust law, but the obligations of the present administration to trusts, as well as the close business relations existing between some of the men who now dominate the Republican party with trusts, are such that nothing short of actual conviction of them would convince anybody that any serious prosecution of trusts will take place under this administration. When the Presidential campaign opens there may be a bluff made towards prosecuting trusts, for the benefit of the very gullible voters.

Montana Volunteer Tells How the Native Fight.

In a letter to friends in Wheeling, W Va., Private W. J. McKee, of Company C. First Montana Volunteer Infantry now in service in the Philippines writes in an interesting vein of the meth ods of warfare of the insurgents. In the

course of his description he says: "We are posted in the rice fields among the brush, and when night darkens the rebels put on citizens' clothing and approach our lines. When we challenge hem they shout "amigo," and as they look like inoffensive civilians they have been permitted to pass. In passing the sentry they watch their chance and jump beneath their white outer garments and attempt to slash him across the throat. Our outposts have been attacked every night, but the troopers have managed to escape without being killed, although many of them have been disfigured for life by the ugly knives carried by the insurgents. Orders have been issued to kill every native who attempts to pass the

Private McKee relates the story of the brave fight of Private Fred Schmidt, of Company F. South Dakota Volunteers. Schmidt was on outpost duty and was attacked by two Filipino warriors in citizens' clothing. One made a dash at Schmidt's throat, cutting away the muscles of one side of his jaw. Although bleeding and terribly slashed over the face, the outpost loaded his musket and shot one of his assailants. The other one ran, but a long-distance shot by the wounded soldier brought him down and his body was found in the rice grass the next morning pierced through. Schmidt will likely receive the military reward his brave conduct deserves.

Early in the afternoon while carrying a despatch from him to Gen. Wheeler's headquarters, I rau into a Spanish skirmish line and bearound me yelling like Comanches. It was too late to turn back. I put spurs to my horse and drawing my revolver, proceeded to empty it into the Dons'

"Well, I felt the conventional 'stinging sensations' several times before I got out of that mess, but I kept straight ahead, loading my revolver as I went and incidently taking an inventory of my wounds. I found I had been shot four times and cut twice with machetes. "A quarter of a mile futher on I ran

into another bunch and again I had to run the gauntlet. The proceeding of three minutes before was repeated. I emptied my revolver and put my horse to his highest speed. This time I was shot three times and received four cuts from machetes, which brought the total number of wounds up to thirteen.

"After this second adventure I had ridden about a mile I guess, when a shell burst near by, killing my horse and breaking my right leg below the knee in six places. I fell to the ground, where I lay until 4 o'clock on the next afternoon. I
