Doctors in Court.

Cases more or less interesting to practleing physicians throughout the State were disposed of before Justice J. F. Melvin here Tuesday. Drs. John W. Lacey and Walter Sims, of the Fourth district; Dr. Arthur Williams, of the First, and Dr. J. T. Waltemeyer, of the Second, were charged with having practiced their profession in Howard county without having filed the required certificate under the recent law in the county clerk's office. Mr. Daniel M. Murray rep resented as counsel Dr. Williams, and Mr Reuben D. Johnson appeared for Dr. Sims, State's Attorney Joseph D. Mc-Guire representing the State. A lively contest arose between opposing counse over the construction of the law governing the cases. Dr. J. McP. Scott, secretary of the State Board of Medical Examiners, was present at the hearings. He gave in an informal way the practice required by the board under its construction of the law. Dr. Williams produced a certificate from the Howard county clerk recently executed; Dr. Sims produced one from the Frederick county Court, and Dr. Waltmeyer one from Baltimore county, Dr. Lacey pleading ignor-

ance of the law altogether. The recent law reads: "Any person who after July 1, 1894, shall practice or attempt to practice medicine or surgery in this state without being registered shall be guilty of a misdemeanor, and shall be fined not less than \$10 nor more than \$200 for each offense.

The Kissing Bug. The melanolestes picipes commonl called the "Kissing Bug," has made its appearance in many parts of Maryland. The bug when full grown is an inch long and is characterized by a flattened body and a very narrow, pointed head. It has a short, strong beak, with a point as sharp as that of a mosquito; is jet black in color and flys at night. It is fond of human blood, and where ever it pierces the skin no special pain is felt, but the part pierced immediately swells to about ten times the normal size. Hospital physicians treat the bite with a solution of collodion. Baking soda is also used.

Old Silk Factory. The successful starting of the silk in dustry at the Thistle factory has revived memories of a silk mill many years ago conducted near Hollofield, in the First district of Baltimore county. The fac-tory was known as the "Watermelon Mills," its name being derived from the shape of the dam of water furnishing power to operate it. Silk worms were also bred on mulberry trees, which surrounded the mill, the ruins of which are still standing.
