Rogers then arose, and in a highly eulogistic speech as to the fitness and experience of Judge Jones for the Chief Judgeship on the bench, placed him in nomination. Judge Jones' nomination was seconded by Guy Steele, of Westminster, and by Ex-Senator Moss, of Annapolis, both of whom also paid warm tributes to the efficiency and worth of Judge Jones. Upon a mo-tion of Ex-Senator Moss, Judge Jones was then nominated by a rising vote,

amid much applause. After the adjournment the delegates in a body waited upon Judge Jones in his office in the Courthouse and formally notified him of his nomination. Judge Jones, in a few well-chosen remarks, ac cepted the nomination and thanked the convention for the honors confered upon him. Many others called and congratulated the Judge on his nomination.
