NEW YORK WHEN DEWEY WAS THERE

A Graphically Written Account of the Great Demonstration. Dr. L. M. Shipley, of West Friendship, has anded us the following letter from his niece Miss Luclla Figgatt, giving her experiences or and impressions of Dewey day in New York It is so entertainingly written that we have concluded to give it space: "Yes, I saw Dewey and waved and shouted in my most approved style. On Sunday my neck was so sore that it was misery for me to put a collar on, from stretching to see all there was to see, and my right arm ached at the was to see and my light at a standard we shoulder from using opera glasses. I really did not need them, but used them because it brought the faces of the most interesting so near to me. I will try and give you a detailed account and if it proves tedious just blame yourself and do not make such a rash request again. Here goes. "The city was packed and jammed and crowded, until it was almost impossible to walk on Broadway and the other principal streets for two days before the celebration. The city was one mass and blaze of color. Every one who had a red, white and blue rag had it out, and in every window were pictures of Dewey. If he had seen some of them I know he would have wished that he had never left Manila. But really some of the decorations were beautiful, and there were some magnificent paintings of Dewey on exhibition at different places. The World and Journal offices were especially fine and so was Wana-maker's. On the bridge were the words, Welcome Dewey, in letters 35 feet in height, and each letter was one mass of little electric lamps: there were thousands of them used. They were lighted at night and could be read at Tompkinsville, which is nine miles down the bay. I saw and could distinguish them away over in South Brooklyn, which is about seven miles from everywhere, and I am nearighted, as you well know. "The Dewey Arch was a thing of beauty and ought to be a joy forever. The figures were very fine and so life-like. It was a pretty sight to see that enormous white object loom-ing up in the air. It is too bad that it is only temporary, for it would be an acquisition to any city. I think it will be perpetuated. It will if some of the newspapers will only take the matter up. Everything was closed in the way of business on Friday and Saturday and way of ourness on Friday and section, and everything and everybody was in holiday attice. It came in for a goodly share of cheering. Then came the first prize captured by us from the Spanish the Buena Ventura. It was followed by all the tugs in the harbor, which are too numerous to count. Then came all the excursion steamers that ply between the different watering places in and around New York, even the Sound steamers and one of the Old Dominion steamrs taking part. They were loaded down to the water's edge with passengers. They cer-tainly were a pretty sight and an unusual one. The river seemed completely filled up with them. All the boats were gayly decorated them. All the boats were gayly decorated with flugs of all descriptions and all nations. There were bands on board of most of them, and the strains floated out across the water and only added to the picturesque scene. I guess there must have been between 2,000 and 2,500 vessels in line. We left after four P. M. and the parade was still passing. We then went up town and saw the Dewey Arch and went through Wanamaker's, where the decorations were very line. They had a flag there rations were very fine. They had a flag there that was worth \$10,000 and it was only about a foot long and half as wide, but it was made of jewels entirely. The white strips were diamonds, the red rubies and the blue sapphires. My, how it did sparkle!
I did not go home that night but went over to Brooklyn with Christine. That night there was an illuminated water parade. A fleet of boatsstarted simultaneously down the North tiver from Grant's Tomb and down the East River from Ward's Island, They were li-luminated and sending off lire works all the way down. They met off the Battery at about 9.30 P. M., and there gave a display of set pieces, the linest display that has ever been given in this city. Papa says the only thing he ever saw that touched it at all was the dispay of fireworks in Venice when the Suitan of Turkey visited that city. There were also fireworks on Bedloe's Island, Madison Square Garden, Mt. Morris Park, Grant's Tomb, Ward's Island and Governor's Island, in New York, and at City Hall and Prospect

Park, in Brooklyn. Oh, you cannot conceive of the beauty of the whole scene. You imagination is not equal to it. One must have seen it to realize it. I never expect to see its equal again. Just at the end of the display it began to rain and thousands of pec display it began to rain and thousands of people got thoroughly wet. There were about 59,060 people at the Battery alone and the trains could not accommodate all of them. Fortunately I was under shelter. Oh, how tired I was that night. We got up the next morning and started for New York, with the rest of our party, at 10 o'clock. We had seats at George Vanderbuilt's house on Fifth Avenue and Fifty-first Street. I have a friend who is an intimate friend of his secretary and who is an intimate friend of his secretary and that is how we obtained them, but it was quite an honor, and the view was fine and we saw everything, for every one knew whose house it was and they would all look that way. "Well, we came across the Bridge and walked over to Sixth avenue to take the "L' train. There was a perfect stream of people going up the stairs but we fell in line and wer going up the stairs but we fell in line and were patiently and slowly climbing up the steps when some people coming down informed us that they had been waiting for a train for over and hour and none of them stopped as they were loaded down and that is about the fifth station from the beginning of the line. We turned around and then went over to the Ninth avenue and found that they had sold all the tickets they had and that all the trains were crowded and it was just about half past were crowded and it was just about half pas ten. It looked very much as if we would have to walk up town a distance of about five miles. We managed to get in a horse car and went across to Third avenue where we took a Cable car and crawled up to Fifty-first Street. It could only crawl on account of the dense crowd. At last we reached our destination as far as Third avenue, but we had to walk across to Fifth avenue, which was accomplished in a very little time as the crowd was not so bad there. But my! when we came to Fitth avenue and tried to cross to the other side! Itlooked about as feasible as crawling through a hay stack without disturbing or destroying the stack. It was just impossible to do so. The people were packed in so tightly that you ould not put your finger between them ome places.
